- 13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 14 That the Laws of Maryland read as follows:

- 17 (a) (1) In this section[, "aging-in-place program"] THE FOLLOWING WORDS
- 18 HAVE THE MEANINGS INDICATED.
- 19 (2) "AGING-IN-PLACE PROGRAM" means a program or service that
- 20 enables an individual to live in the individual's own home and community safely,
- 21 independently, and comfortably, regardless of age, income, or ability level.
- 22 (3) "SENIOR VILLAGE" MEANS A LOCAL, MEMBER-DRIVEN,
- 23 NONPROFIT ORGANIZATION THAT:

(e) The Department shall publicize the availability of grant opportunities under the aging—in—place program to eligible organizations at least 6 weeks before grant applications are due.

- 1 (f) The amount of the State grant for an aging—in—place program shall be 2 determined after consideration of:
- 3 (1) all eligible applicants;
- 4 (2) the total amount of State funds available for grants; and
- 5 (3) the priorities of area need as may be established by the Department in consultation with area agencies on aging and in alignment with area plans on aging.
- Funding for the State grants under this section shall be as provided by the Sovernor in the annual State budget.]
- 9 (G) (1) FOR EACH FISCAL YEAR, THE GOVERNOR SHALL INCLUDE IN THE 10 ANNUAL BUDGET BILL AN APPROPRIATION OF AT LEAST \$1,000,000 FOR THE 11 PURPOSE OF MAKING THE STATE GRANTS UNDER THIS SECTION.
- 12 **(2)** AT LEAST 10% OF THE FUNDING APPROPRIATED UNDER 13 PARAGRAPH (1) OF THIS SUBSECTION SHALL BE USED TO SUPPORT SENIOR 14 VILLAGES.
- 15 (h) The Department shall notify an area agency on aging within 2 weeks after a grant award to a nonprofit located within the jurisdiction of the area agency on aging.
