BY adding to Article – Transportation Section 13–936.3 Annotated Code of Maryland (2020 Replacement Volume and 2023 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND. That the Laws of Maryland read as follows: **Article – Transportation** 13-936.3. (A) IN THIS SECTION, "MILITARY VEHICLE" MEANS A WHEELED.

15 16 17 18	(2) THE ADMINISTRATION, IN CONSULTATION WITH THE DEPARTMENT OF STATE POLICE AND MILITARY VEHICLE OWNERS IN THE STATE SHALL DEVELOP A SAFETY INSPECTION AND A SAFETY INSPECTION PROCESS FOR MILITARY VEHICLES.
19 20 21	(G) (1) A MILITARY VEHICLE REGISTERED UNDER A DIFFERENT REGISTRATION CLASS BEFORE OCTOBER 1, 2024, MAY CONTINUE TO BE REGISTERED UNDER THAT REGISTRATION CLASS.
22 23 24	(2) IF A MILITARY VEHICLE REGISTERED UNDER A DIFFERENT REGISTRATION CLASS IS TRANSFERRED TO A NEW OWNER, THE MILITARY VEHICLE SHALL BE REGISTERED UNDER THIS SECTION.
