**A BILL**

To amend section 4501.21 and to enact section 1  
4503.88 of the Revised Code to create the 2  
"Kenston Local Schools" license plate. 3

**BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:**

**Section 1.** That section 4501.21 be amended and section 4  
4503.88 of the Revised Code be enacted to read as follows: 5

**Sec. 4501.21.** (A) There is hereby created in the state 6  
treasury the license plate contribution fund. The fund shall 7  
consist of all contributions paid by motor vehicle registrants 8  
and collected by the registrar of motor vehicles pursuant to 9  
sections 4503.491, 4503.492, 4503.493, 4503.494, 4503.495, 10  
4503.496, 4503.497, 4503.498, 4503.499, 4503.50, 4503.501, 11  
4503.502, 4503.505, 4503.51, 4503.514, 4503.522, 4503.523, 12  
4503.524, 4503.525, 4503.526, 4503.528, 4503.529, 4503.531, 13  
4503.534, 4503.545, 4503.55, 4503.551, 4503.552, 4503.553, 14  
4503.554, 4503.555, 4503.556, 4503.561, 4503.562, 4503.564, 15  
4503.565, 4503.576, 4503.577, 4503.591, 4503.592, 4503.67, 16  
4503.68, 4503.69, 4503.701, 4503.702, 4503.71, 4503.711, 17  
4503.712, 4503.713, 4503.715, 4503.72, 4503.722, 4503.73, 18  
4503.732, 4503.733, 4503.74, 4503.75, 4503.751, 4503.752, 19

4503.763, 4503.85, 4503.86, 4503.87, 4503.871, 4503.874,  
4503.877, 4503.88, 4503.89, 4503.90, 4503.901, 4503.902,  
4503.903, 4503.904, 4503.92, 4503.94, 4503.97, and 4503.98 of  
the Revised Code.

(B) The registrar shall pay the contributions the  
registrar collects in the fund as follows:

The registrar shall pay the contributions received  
pursuant to section 4503.491 of the Revised Code to the breast  
cancer fund of Ohio, which shall use that money only to pay for  
programs that provide assistance and education to Ohio breast  
cancer patients and that improve access for such patients to  
quality health care and clinical trials and shall not use any of  
the money for abortion information, counseling, services, or  
other abortion-related activities.

The registrar shall pay the contributions the registrar  
receives pursuant to section 4503.492 of the Revised Code to the  
organization cancer support community central Ohio, which shall  
deposit the money into the Sheryl L. Kraner Fund of that  
organization. Cancer support community central Ohio shall expend  
the money it receives pursuant to this division only in the same  
manner and for the same purposes as that organization expends  
other money in that fund.

The registrar shall pay the contributions received  
pursuant to section 4503.493 of the Revised Code to the autism  
society of Ohio, which shall use the contributions for programs  
and autism awareness efforts throughout the state.

The registrar shall pay the contributions the registrar  
receives pursuant to section 4503.494 of the Revised Code to the  
national multiple sclerosis society for distribution in equal

amounts to the northwestern Ohio, Ohio buckeye, and Ohio valley 49  
chapters of the national multiple sclerosis society. These 50  
chapters shall use the money they receive under this section to 51  
assist in paying the expenses they incur in providing services 52  
directly to their clients. 53

The registrar shall pay the contributions the registrar 54  
receives pursuant to section 4503.495 of the Revised Code to the 55  
national pancreatic cancer foundation, which shall use the money 56  
it receives under this section to assist those who suffer with 57  
pancreatic cancer and their families. 58

The registrar shall pay the contributions the registrar 59  
receives pursuant to section 4503.496 of the Revised Code to the 60  
Ohio sickle cell and health association, which shall use the 61  
contributions to help support educational, clinical, and social 62  
support services for adults who have sickle cell disease. 63

The registrar shall pay the contributions the registrar 64  
receives pursuant to section 4503.497 of the Revised Code to the 65  
St. Baldrick's foundation, which shall use the contributions for 66  
its research and other programs. 67

The registrar shall pay the contributions the registrar 68  
receives pursuant to section 4503.498 of the Revised Code to 69  
special olympics Ohio, inc., which shall use the contributions 70  
for its programs, charitable efforts, and other activities. 71

The registrar shall pay the contributions the registrar 72  
receives pursuant to section 4503.499 of the Revised Code to the 73  
children's glioma cancer foundation, which shall use the 74  
contributions for its research and other programs. 75

The registrar shall pay the contributions the registrar 76  
receives pursuant to section 4503.50 of the Revised Code to the 77

future farmers of America foundation, which shall deposit the 78  
contributions into its general account to be used for 79  
educational and scholarship purposes of the future farmers of 80  
America foundation. 81

The registrar shall pay the contributions the registrar 82  
receives pursuant to section 4503.501 of the Revised Code to the 83  
4-H youth development program of the Ohio state university 84  
extension program, which shall use those contributions to pay 85  
the expenses it incurs in conducting its educational activities. 86

The registrar shall pay the contributions received 87  
pursuant to section 4503.502 of the Revised Code to the Ohio 88  
cattlemen's foundation, which shall use those contributions for 89  
scholarships and other educational activities. 90

The registrar shall pay the contributions received 91  
pursuant to section 4503.505 of the Revised Code to the 92  
organization Ohio region phi theta kappa, which shall use those 93  
contributions for scholarships for students who are members of 94  
that organization. 95

The registrar shall pay each contribution the registrar 96  
receives pursuant to section 4503.51 of the Revised Code to the 97  
university or college whose name or marking or design appears on 98  
collegiate license plates that are issued to a person under that 99  
section. A university or college that receives contributions 100  
from the fund shall deposit the contributions into its general 101  
scholarship fund. 102

The registrar shall pay the contributions the registrar 103  
receives pursuant to section 4503.514 of the Revised Code to the 104  
university of Notre Dame in South Bend, Indiana, for purposes of 105  
awarding grants or scholarships to residents of Ohio who attend 106

the university. The university shall not use more than twenty 107  
per cent of the funds it receives for purposes of administering 108  
the scholarship program. The registrar shall enter into 109  
appropriate agreements with the university of Notre Dame to 110  
effectuate the distribution of such funds as provided in this 111  
section. 112

The registrar shall pay the contributions the registrar 113  
receives pursuant to section 4503.522 of the Revised Code to the 114  
"friends of Perry's victory and international peace memorial, 115  
incorporated," a nonprofit corporation organized under the laws 116  
of this state, to assist that organization in paying the 117  
expenses it incurs in sponsoring or holding charitable, 118  
educational, and cultural events at the monument. 119

The registrar shall pay the contributions the registrar 120  
receives pursuant to section 4503.523 of the Revised Code to the 121  
fairport lights foundation, which shall use the money to pay for 122  
the restoration, maintenance, and preservation of the 123  
lighthouses of fairport harbor. 124

The registrar shall pay the contributions the registrar 125  
receives pursuant to section 4503.524 of the Revised Code to the 126  
Massillon tiger football booster club, which shall use the 127  
contributions only to promote and support the football team of 128  
Washington high school of the Massillon city school district. 129

The registrar shall pay the contributions the registrar 130  
receives pursuant to section 4503.525 of the Revised Code to the 131  
United States power squadron districts seven, eleven, twenty- 132  
four, and twenty-nine in equal amounts. Each power squadron 133  
district shall use the money it receives under this section to 134  
pay for the educational boating programs each district holds or 135  
sponsors within this state. 136

The registrar shall pay the contributions the registrar receives pursuant to section 4503.526 of the Revised Code to the Ohio district Kiwanis foundation of the Ohio district of Kiwanis international, which shall use the money it receives under this section to pay the costs of its educational and humanitarian activities.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.528 of the Revised Code to the Ohio association of child caring agencies, which shall use the money it receives under this section to pay the expenses it incurs in advancing its mission of sustainably improving the provision of services to children, young adults, and families in this state.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.529 of the Revised Code to the Ohio nurses foundation. The foundation shall use the money it receives under this section to provide educational scholarships to assist individuals who aspire to join the nursing profession, to assist nurses in the nursing profession who seek to advance their education, and to support persons conducting nursing research concerning the evidence-based practice of nursing and the improvement of patient outcomes.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.531 of the Revised Code to the thank you foundation, incorporated, a nonprofit corporation organized under the laws of this state, to assist that organization in paying for the charitable activities and programs it sponsors in support of United States military personnel, veterans, and their families.

The registrar shall pay the contributions the registrar

receives pursuant to section 4503.534 of the Revised Code to the 167  
disabled American veterans department of Ohio, to be used for 168  
programs that serve disabled American veterans and their 169  
families. 170

The registrar shall pay the contributions the registrar 171  
receives pursuant to section 4503.55 of the Revised Code to the 172  
pro football hall of fame, which shall deposit the contributions 173  
into a special bank account that it establishes and which shall 174  
be separate and distinct from any other account the pro football 175  
hall of fame maintains, to be used exclusively for the purpose 176  
of promoting the pro football hall of fame as a travel 177  
destination. 178

The registrar shall pay the contributions that are paid to 179  
the registrar pursuant to section 4503.545 of the Revised Code 180  
to the national rifle association foundation, which shall use 181  
the money to pay the costs of the educational activities and 182  
programs the foundation holds or sponsors in this state. 183

The registrar shall pay to the Ohio pet fund the 184  
contributions the registrar receives pursuant to section 185  
4503.551 of the Revised Code and any other money from any other 186  
source, including donations, gifts, and grants, that is 187  
designated by the source to be paid to the Ohio pet fund. The 188  
Ohio pet fund shall use the moneys it receives under this 189  
section to support programs for the sterilization of dogs and 190  
cats and for educational programs concerning the proper 191  
veterinary care of those animals, and for expenses of the Ohio 192  
pet fund that are reasonably necessary for it to obtain and 193  
maintain its tax-exempt status and to perform its duties. 194

The registrar shall pay the contributions the registrar 195  
receives pursuant to section 4503.552 of the Revised Code to the 196

rock and roll hall of fame and museum, incorporated. 197

The registrar shall pay the contributions the registrar 198  
receives pursuant to section 4503.553 of the Revised Code to the 199  
Ohio coalition for animals, incorporated, a nonprofit 200  
corporation. Except as provided in division (B) of this section, 201  
the coalition shall distribute the money to its members, and the 202  
members shall use the money only to pay for educational, 203  
charitable, and other programs of each coalition member that 204  
provide care for unwanted, abused, and neglected horses. The 205  
Ohio coalition for animals may use a portion of the money to pay 206  
for reasonable marketing costs incurred in the design and 207  
promotion of the license plate and for administrative costs 208  
incurred in the disbursement and management of funds received 209  
under this section. 210

The registrar shall pay the contributions the registrar 211  
receives pursuant to section 4503.554 of the Revised Code to the 212  
Ohio state council of the knights of Columbus, which shall use 213  
the contributions to pay for its charitable activities and 214  
programs. 215

The registrar shall pay the contributions the registrar 216  
receives pursuant to section 4503.555 of the Revised Code to the 217  
western reserve historical society, which shall use the 218  
contributions to fund the Crawford auto aviation museum. 219

The registrar shall pay the contributions the registrar 220  
receives pursuant to section 4503.556 of the Revised Code to the 221  
Erica J. Holloman foundation, inc., for the awareness of triple 222  
negative breast cancer. The foundation shall use the 223  
contributions for charitable and educational purposes. 224

The registrar shall pay the contributions the registrar 225



receives pursuant to section 4503.561 of the Revised Code to the 226  
state of Ohio chapter of ducks unlimited, inc., which shall 227  
deposit the contributions into a special bank account that it 228  
establishes. The special bank account shall be separate and 229  
distinct from any other account the state of Ohio chapter of 230  
ducks unlimited, inc., maintains and shall be used exclusively 231  
for the purpose of protecting, enhancing, restoring, and 232  
managing wetlands and conserving wildlife habitat. The state of 233  
Ohio chapter of ducks unlimited, inc., annually shall notify the 234  
registrar in writing of the name, address, and account to which 235  
such payments are to be made. 236

The registrar shall pay the contributions the registrar 237  
receives pursuant to section 4503.562 of the Revised Code to the 238  
Mahoning river consortium, which shall use the money to pay the 239  
expenses it incurs in restoring and maintaining the Mahoning 240  
river watershed. 241

The registrar shall pay the contributions the registrar 242  
receives pursuant to section 4503.564 of the Revised Code to 243  
Antioch college for the use of the Glen Helen ecology institute 244  
to pay expenses related to the Glen Helen nature preserve. 245

The registrar shall pay the contributions the registrar 246  
receives pursuant to section 4503.565 of the Revised Code to the 247  
conservancy for Cuyahoga valley national park, which shall use 248  
the money in support of the park. 249

The registrar shall pay the contributions the registrar 250  
receives pursuant to section 4503.576 of the Revised Code to the 251  
Ohio state beekeepers association, which shall use those 252  
contributions to promote beekeeping, provide educational 253  
information about beekeeping, and to support other state and 254  
local beekeeping programs. 255

The registrar shall pay the contributions the registrar receives pursuant to section 4503.577 of the Revised Code to the national aviation hall of fame, which shall use the contributions to fulfill its mission of honoring aerospace legends to inspire future leaders.

The registrar shall pay to a sports commission created pursuant to section 4503.591 of the Revised Code each contribution the registrar receives under that section that an applicant pays to obtain license plates that bear the logo of a professional sports team located in the county of that sports commission and that is participating in the license plate program pursuant to division (E) of that section, irrespective of the county of residence of an applicant.

The registrar shall pay to a community charity each contribution the registrar receives under section 4503.591 of the Revised Code that an applicant pays to obtain license plates that bear the logo of a professional sports team that is participating in the license plate program pursuant to division (G) of that section.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.592 of the Revised Code to pollinator partnership's monarch wings across Ohio program, which shall use the contributions for the protection and preservation of the monarch butterfly and pollinator corridor in Ohio and for educational programs.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.67 of the Revised Code to the Dan Beard council of the boy scouts of America. The council shall distribute all contributions in an equitable manner throughout the state to regional councils of the boy scouts.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.68 of the Revised Code to the great river council of the girl scouts of the United States of America. The council shall distribute all contributions in an equitable manner throughout the state to regional councils of the girl scouts.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.69 of the Revised Code to the Dan Beard council of the boy scouts of America. The council shall distribute all contributions in an equitable manner throughout the state to regional councils of the boy scouts.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.701 of the Revised Code to the Prince Hall grand lodge of free and accepted masons of Ohio, which shall use the contributions for scholarship purposes.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.702 of the Revised Code to the Ohio Association of the Improved Benevolent and Protective Order of the Elks of the World, which shall use the funds for charitable purposes.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.71 of the Revised Code to the fraternal order of police of Ohio, incorporated, which shall deposit the fees into its general account to be used for purposes of the fraternal order of police of Ohio, incorporated.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.711 of the Revised Code to the fraternal order of police of Ohio, incorporated, which shall deposit the contributions into an account that it creates to be

used for the purpose of advancing and protecting the law 315  
enforcement profession, promoting improved law enforcement 316  
methods, and teaching respect for law and order. 317

The registrar shall pay the contributions received 318  
pursuant to section 4503.712 of the Revised Code to Ohio 319  
concerns of police survivors, which shall use those 320  
contributions to provide whatever assistance may be appropriate 321  
to the families of Ohio law enforcement officers who are killed 322  
in the line of duty. 323

The registrar shall pay the contributions received 324  
pursuant to section 4503.713 of the Revised Code to the greater 325  
Cleveland peace officers memorial society, which shall use those 326  
contributions to honor law enforcement officers who have died in 327  
the line of duty and support its charitable purposes. 328

The registrar shall pay the contributions the registrar 329  
receives pursuant to section 4503.715 of the Revised Code to the 330  
fallen linemen organization, which shall use the contributions 331  
to recognize and memorialize fallen linemen and support their 332  
families. 333

The registrar shall pay the contributions the registrar 334  
receives pursuant to section 4503.72 of the Revised Code to the 335  
organization known on March 31, 2003, as the Ohio CASA/GAL 336  
association, a private, nonprofit corporation organized under 337  
Chapter 1702. of the Revised Code. The Ohio CASA/GAL association 338  
shall use these contributions to pay the expenses it incurs in 339  
administering a program to secure the proper representation in 340  
the courts of this state of abused, neglected, and dependent 341  
children, and for the training and supervision of persons 342  
participating in that program. 343

The registrar shall pay the contributions the registrar 344  
receives pursuant to section 4503.722 of the Revised Code to the 345  
Down Syndrome Association of Central Ohio, which shall use the 346  
contributions for advocacy purposes throughout the state. 347

The registrar shall pay the contributions the registrar 348  
receives pursuant to section 4503.73 of the Revised Code to 349  
Wright B. Flyer, incorporated, which shall deposit the 350  
contributions into its general account to be used for purposes 351  
of Wright B. Flyer, incorporated. 352

The registrar shall pay the contributions the registrar 353  
receives pursuant to section 4503.732 of the Revised Code to the 354  
Siegel & Shuster society, a nonprofit organization dedicated to 355  
commemorating and celebrating the creation of Superman in 356  
Cleveland, Ohio. 357

The registrar shall pay the contributions the registrar 358  
receives pursuant to section 4503.733 of the Revised Code to the 359  
Ohio chapter of the juvenile diabetes research foundation in 360  
whose geographic territory the person who paid the contribution 361  
resides. 362

The registrar shall pay the contributions the registrar 363  
receives pursuant to section 4503.74 of the Revised Code to the 364  
Columbus zoological park association, which shall disburse the 365  
moneys to Ohio's major metropolitan zoos, as defined in section 366  
4503.74 of the Revised Code, in accordance with a written 367  
agreement entered into by the major metropolitan zoos. 368

The registrar shall pay the contributions the registrar 369  
receives pursuant to section 4503.75 of the Revised Code to the 370  
rotary foundation, located on March 31, 2003, in Evanston, 371  
Illinois, to be placed in a fund known as the permanent fund and 372

used to endow educational and humanitarian programs of the 373  
rotary foundation. 374

The registrar shall pay the contributions the registrar 375  
receives pursuant to section 4503.751 of the Revised Code to the 376  
Ohio association of realtors, which shall deposit the 377  
contributions into a property disaster relief fund maintained 378  
under the Ohio realtors charitable and education foundation. 379

The registrar shall pay the contributions the registrar 380  
receives pursuant to section 4503.752 of the Revised Code to 381  
buckeye corvettes, incorporated, which shall use the 382  
contributions to pay for its charitable activities and programs. 383

The registrar shall pay the contributions the registrar 384  
receives pursuant to section 4503.763 of the Revised Code to the 385  
Ohio history connection to be used solely to build, support, and 386  
maintain the Ohio battleflag collection within the Ohio history 387  
connection. 388

The registrar shall pay the contributions the registrar 389  
receives pursuant to section 4503.85 of the Revised Code to the 390  
Ohio sea grant college program to be used for Lake Erie area 391  
research projects. 392

The registrar shall pay the contributions the registrar 393  
receives pursuant to section 4503.86 of the Revised Code to the 394  
Ohio Lincoln highway historic byway, which shall use those 395  
contributions solely to promote and support the historical 396  
preservation and advertisement of the Lincoln highway in this 397  
state. 398

The registrar shall pay the contributions the registrar 399  
receives pursuant to section 4503.87 of the Revised Code to the 400  
Grove City little league dream field fund, which shall use those 401

contributions solely to build, maintain, and improve youth 402  
baseball fields within the municipal corporation of Grove City. 403

The registrar shall pay the contributions the registrar 404  
receives pursuant to section 4503.871 of the Revised Code to the 405  
Solon city school district. The school district shall use the 406  
contributions it receives to pay the expenses it incurs in 407  
providing services to the school district's students that assist 408  
in developing or maintaining the mental and emotional well-being 409  
of the students. The services provided may include bereavement 410  
counseling, instruction in defensive driving techniques, 411  
sensitivity training, and the counseling and education of 412  
students regarding bullying, dating violence, drug abuse, 413  
suicide prevention, and human trafficking. The school district 414  
superintendent or, in the school district superintendent's 415  
discretion, the appropriate school principal or appropriate 416  
school counselors shall determine any charitable organizations 417  
that the school district hires to provide those services. The 418  
school district also may use the contributions it receives to 419  
pay for members of the faculty of the school district to receive 420  
training in providing such services to the students of the 421  
school district. The school district shall ensure that any 422  
charitable organization that is hired by the district is exempt 423  
from federal income taxation under subsection 501(c)(3) of the 424  
Internal Revenue Code. The school district shall not use the 425  
contributions it receives for any other purpose. 426

The registrar shall pay the contributions the registrar 427  
receives pursuant to section 4503.874 of the Revised Code to St. 428  
Edward high school located in the municipal corporation of 429  
Lakewood. The school shall use fifty per cent of the 430  
contributions it receives to provide tuition assistance to its 431  
students. The school shall use the remaining fifty per cent to 432

pay the expenses it incurs in providing services to the school's 433  
students that assist in developing or maintaining the mental and 434  
emotional well-being of the students. The services provided may 435  
include bereavement counseling, instruction in defensive driving 436  
techniques, sensitivity training, and the counseling and 437  
education of students regarding bullying, dating violence, drug 438  
abuse, suicide prevention, and human trafficking. As a part of 439  
providing such services, the school may pay for members of the 440  
faculty of the school to receive training in providing those 441  
services. The school principal or, in the school principal's 442  
discretion, appropriate school counselors shall determine any 443  
charitable organizations that the school hires to provide those 444  
services. The school shall ensure that any such charitable 445  
organization is exempt from federal income taxation under 446  
subsection 501(c)(3) of the Internal Revenue Code. The school 447  
shall not use the contributions it receives for any other 448  
purpose. 449

The registrar shall pay the contributions the registrar 450  
receives pursuant to section 4503.877 of the Revised Code to the 451  
Independence local school district. The school district shall 452  
use the contributions it receives to pay the expenses it incurs 453  
in providing services to the school district's students that 454  
assist in developing or maintaining the mental and emotional 455  
well-being of the students. The services provided may include 456  
bereavement counseling, instruction in defensive driving 457  
techniques, sensitivity training, and the counseling and 458  
education of students regarding bullying, dating violence, drug 459  
abuse, suicide prevention, and human trafficking. The school 460  
district superintendent or, in the school district 461  
superintendent's discretion, the appropriate school principal or 462  
appropriate school counselors shall determine any charitable 463



organizations that the school district hires to provide those 464  
services. The school district also may use the contributions it 465  
receives to pay for members of the faculty of the school 466  
district to receive training in providing such services to the 467  
students of the school district. The school district shall 468  
ensure that any charitable organization that is hired by the 469  
district is exempt from federal income taxation under subsection 470  
501(c)(3) of the Internal Revenue Code. The school district 471  
shall not use the contributions it receives for any other 472  
purpose. 473

The registrar shall pay the contributions the registrar 474  
receives pursuant to section 4503.88 of the Revised Code to the 475  
Kenston local school district. The school district shall use the 476  
contributions it receives to pay the expenses it incurs in 477  
providing services that assist in developing or maintaining a 478  
culture of environmental responsibility and an innovative 479  
science, technology, engineering, art, and math (S.T.E.A.M.) 480  
curriculum to the school district's students. The school 481  
district shall not use the contributions it receives for any 482  
other purpose. 483

The registrar shall pay the contributions the registrar 484  
receives pursuant to section 4503.89 of the Revised Code to the 485  
American red cross of greater Columbus on behalf of the Ohio 486  
chapters of the American red cross, which shall use the 487  
contributions for disaster readiness, preparedness, and response 488  
programs on a statewide basis. 489

The registrar shall pay the contributions the registrar 490  
receives pursuant to section 4503.90 of the Revised Code to the 491  
nationwide children's hospital foundation. 492

The registrar shall pay the contributions the registrar 493

receives pursuant to section 4503.901 of the Revised Code to the 494  
Ohio association for pupil transportation, which shall use the 495  
money to support transportation programs, provide training to 496  
school transportation professionals, and support other 497

The registrar shall pay the contributions the registrar 499  
receives pursuant to section 4503.902 of the Revised Code to St. 500  
Ignatius high school located in the municipal corporation of 501  
Cleveland. The school shall use fifty per cent of the 502  
contributions it receives to provide tuition assistance to its 503  
students. The school shall use the remaining fifty per cent to 504  
pay the expenses it incurs in providing services to the school's 505  
students that assist in developing or maintaining the mental and 506  
emotional well-being of the students. The services provided may 507  
include bereavement counseling, instruction in defensive driving 508  
techniques, sensitivity training, and the counseling and 509  
education of students regarding bullying, dating violence, drug 510  
abuse, suicide prevention, and human trafficking. As a part of 511  
providing such services, the school may pay for members of the 512  
faculty of the school to receive training in providing those 513  
services. The school principal or, in the school principal's 514  
discretion, appropriate school counselors shall determine any 515  
charitable organizations that the school hires to provide those 516  
services. The school shall ensure that any such charitable 517  
organization is exempt from federal income taxation under 518  
subsection 501(c)(3) of the Internal Revenue Code. The school 519  
shall not use the contributions it receives for any other 520  
purpose. 521

The registrar shall pay the contributions the registrar 522  
receives pursuant to section 4503.903 of the Revised Code to the 523  
Brecksville-Broadview Heights city school district. The school 524

district shall use the contributions it receives to pay the 525  
expenses it incurs in providing services to the school 526  
district's students that assist in developing or maintaining the 527

Michelle's leading star foundation, which shall use the money 579  
solely to fund the rental, lease, or purchase of the simulated 580  
driving curriculum of the Michelle's leading star foundation by 581  
boards of education of city, exempted village, local, and joint 582  
vocational school districts. 583

The registrar shall pay the contributions the registrar 584  
receives pursuant to section 4503.97 of the Revised Code to the 585

friends of united Hatzalah of Israel, which shall use the money 586  
to support united Hatzalah of Israel, which provides free 587  
emergency medical first response throughout Israel. 588

The registrar shall pay the contributions the registrar 589  
receives pursuant to section 4503.98 of the Revised Code to the 590  
Westerville parks foundation to support the programs and 591  
activities of the foundation and its mission of pursuing the 592  
city of Westerville's vision of becoming "A City Within A Park." 593

(C) All investment earnings of the license plate 594  
contribution fund shall be credited to the fund. Not later than 595  
the first day of May of every year, the registrar shall 596  
distribute to each entity described in division (B) of this 597  
section the investment income the fund earned the previous 598  
calendar year. The amount of such a distribution paid to an 599  
entity shall be proportionate to the amount of money the entity 600  
received from the fund during the previous calendar year. 601

**Sec. 4503.88.** (A) The owner or lessee of any passenger 602  
car, noncommercial motor vehicle, recreational vehicle, 603  
motorcycle, cab-enclosed motorcycle, motor-driven cycle, motor 604  
scooter, or other vehicle of a class approved by the registrar 605  
of motor vehicles, may apply to the registrar for the 606  
registration of the vehicle and issuance of "Kenston Local 607  
Schools" license plates. An application made under this section 608  
may be combined with a request for a special reserved license 609  
plate under section 4503.40 or 4503.42 of the Revised Code. Upon 610  
receipt of the completed application and compliance by the 611

plates shall be inscribed with words and markings selected by

registration as required under section 4503.19 of the Revised  
Code.

**Section 2.** That existing section 4501.21 of the Revised 650  
Code is hereby repealed. 651

**Section 3.** Section 4501.21 of the Revised Code is 652  
presented in this act as a composite of the section as amended 653  
by both Sub. H.B. 455 and Am. S.B. 207 of the 131st General 654  
Assembly. The General Assembly, applying the principle stated in 655  
division (B) of section 1.52 of the Revised Code that amendments 656  
are to be harmonized if reasonably capable of simultaneous 657  
operation, finds that the composite is the resulting version of 658  
the section in effect prior to the effective date of the section 659
