## A BILL

To protect the right of individuals to bear arms at water resources development projects administered by the Secretary of the Army, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Recreational Lands
- 5 Self-Defense Act of 2017".

#### 1 SEC. 2. PROTECTING AMERICANS FROM VIOLENT CRIME.

- 2 (a) FINDINGS.—Congress finds the following:
- 3 (1) The Second Amendment to the Constitution 4 provides that "the right of the people to keep and 5 bear Arms, shall not be infringed".
- 6 (2) Section 327.13 of title 36, Code of Federal 7 Regulations, provides that, except in special circumstances, "possession of loaded firearms, ammu-8 9 nition, loaded projectile firing devices, bows and ar-10 rows, crossbows, or other weapons is prohibited" at 11 water resources development projects administered 12 by the Secretary of the Army.
  - (3) The regulations described in paragraph (2) prevent individuals complying with Federal and State laws from exercising the Second Amendment rights of the individuals while at such water resources development projects.
- 18 (4) The Federal laws should make it clear that 19 the Second Amendment rights of an individual at a 20 water resources development project should not be infringed.
- 22 (b) Protecting the Right of Individuals To 23 Bear Arms at Water Resources Development
- PROJECTS.—The Secretary of the Army shall not promul-24
- gate or enforce any regulation that prohibits an individual
- from possessing a firearm, including an assembled, func-

- 1 tional, or loaded firearm, at a water resources development
- 2 project covered under section 327.0 of title 36, Code of
- 3 Federal Regulations (as in effect on the date of enactment
- 4 of this Act), if—
- 5 (1) the individual is not otherwise prohibited by
- 6 law from possessing the firearm; and
- 7 (2) the possession of the firearm is in compli-
- 8 ance with the law of the State in which the water
- 9 resources development project is located.
