- 16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 17 That the Laws of Maryland read as follows:

- 20 (a) There is a Division of Pretrial Detention and Services in the Department.
- 21 (b) The Division consists of:
- 22 (1) a Pretrial Release Services Program;

- 2 (a) On the recommendation of a healthcare provider, the [warden] FACILITY
 3 ADMINISTRATOR of the [Baltimore City Detention Center] YOUTH DETENTION CENTER
 4 and the [warden's] FACILITY ADMINISTRATOR'S designees may authorize medical
 5 treatment of a juvenile inmate when in the judgment of the [warden] FACILITY
 6 ADMINISTRATOR or a designee the treatment is required and a parent, guardian, or person
 7 in loco parentis of the juvenile is not available on a timely basis to give the authorization.
- 8 (b) The [warden] FACILITY ADMINISTRATOR or the [warden's] FACILITY 9 ADMINISTRATOR'S designees may not be held liable for authorizing medical treatment 10 under this section in good faith.
