Dear Chairman Mendelson:

Enclosed for consideration and approval by the Council of the District of Columbia is proposed emergency legislation entitled, the "Contract No. DCHT-2016-C-0017 with FEi.com, Inc. d/b/a FEi Systems Emergency Approval Resolution of 2017" and the corresponding declaration resolution to approve multiyear Contract No. DCHT-2016-C-0017 to provide a new clinical case management system to the Department of Health Care Finance. Approval is necessary to allow the District to continue to receive the benefit of these vital services without interruption, and the critical requirements of the District can only be met through an award of the approved multiyear contract to FEi.com, Inc. d/b/a FEi Systems.

Council approval is required by section 451(c)(3) of the District of Columbia Home Rule Act, approved December 24, 1973, 87 Stat. 803, Pub. L. 93-198; D.C. Official Code § 1-204.51(c)(3).

The term of contract will be two (2) years from the date of award at an estimated price of \$3,811,052.94. The Chief Financial Officer for the Department of Health Care Finance has certified that funding is available for FY 2017.
