A BILL

To establish the Medgar Evers Home National Monument in the State of Mississippi, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Medgar and Myrlie

5 Evers Home National Monument Act".

1 SEC. 2. DEFINITIONS.

| 20 | SEC. 3. ESTABLISHMENT OF MEDGAR AND MYRLIE EVERS |

| 5 | (2) DETERMINATION BY THE SECRETARY.— |
| 6 | The Monument shall not be established until the |

| 8 | cient quantity of land or interests in land has been |
| 9 | acquired to constitute a manageable park unit. |
| 10 | (b) BOUNDARIES.—The boundaries of the Monument |
| 11 | shall be the boundaries generally depicted on the Map. |
| 12 | (c) AVAILABILITY OF MAP.—The Map shall be on file |
| 13 | and available for public inspection in the appropriate of- |
| 14 | fices of the National Park Service. |
| 15 | (d) Acquisition Authority.—The Secretary may |
| 16 | only acquire any land or interest in land located within |
| 17 | the boundary of the Monument by— |

| (A) IN GENERAL.—Not later than 3 years |
| after the date on which funds are first made |
| available to the Secretary for this purpose, the |
| Secretary shall prepare a general management |
| plan for the Monument in accordance with sec- |
| tion 100502 of title 54, United States Code. |
| (B) SUBMISSION.—On completion of the |
| general management plan under subparagraph |
| (A), the Secretary shall submit it to the Com- |
| mittee on Natural Resources of the House of |
| Representatives and the Committee on Energy |
| and Natural Resources of the Senate. |
| (f) Agreements.— |
| (1) MONUMENT.—The Secretary— |
| (A) shall seek to enter into an agreement |
| with the College to provide interpretive and |
| |

educational services relating to the Monument; and

3 (B) may enter into agreements with the
4 College and other entities for the purposes of
5 carrying out this Act.

6 (2) HISTORIC DISTRICT.—The Secretary may 7 enter into agreements with the owner of a nationally 8 significant property within the Historic District, to 9 identify, mark, interpret, and provide technical as-10 sistance with respect to the preservation and inter-11 pretation of the property.

12 (g) NO BUFFER ZONES.—

(1) IN GENERAL.—Nothing in this Act, the establishment of the Monument, or the management of
the Monument creates a buffer zone outside of the
Monument.

17 (2) ACTIVITY OR USE OUTSIDE MONUMENT.—
18 The fact that an activity or use can be seen, heard,
19 or detected from within the Monument shall not pre20 clude the conduct of the activity or use outside of
21 the Monument.
