- FOR the purpose of prohibiting a person from engaging in exhibition driving within a special event zone in Worcester County; prohibiting a person from committing certain violations of the Maryland Vehicle Law within a special event zone in Worcester County; defining the term "exhibition driving" for purposes of this Act; establishing certain penalties for violations of this Act; altering a certain definition; making stylistic changes; making this Act an emergency measure; and generally relating to special event zones in Worcester County.

- 20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

(a) (1) 2 "Special event" means any automotive or motor vehicle event occurring (2)3 on or in close proximity to a highway that: 4 (i) Has been permitted or approved by a unit of local government; or Is expected to have 1,000 or more individuals in attendance, 5 (ii) 6 regardless of whether the event has been permitted or approved by a unit of local 7 government. "Special event zone" means an area on or alongside a highway that is 8 9 marked by appropriate warning signs or other traffic control devices designating that a special event is in progress. 10 11 (b) This section applies only in Worcester County. 12 (c) (1) The State Highway Administration may, on its own initiative or at the 13 request of a local authority: 14 (i) Designate an area on a State highway as a special event zone; 15 and 16 Reduce established speed limits in the special event zone after a (ii) 17 determination that the change is necessary to ensure public safety. 18 (2) A local authority may: 19 Designate an area on a highway under its jurisdiction as a 20 special event zone; and 21Reduce established speed limits in the special event zone after a 22 determination that the change is necessary to ensure public safety. 23 A speed limit established under this section shall become effective when (d) posted. 2425A person may not drive a motor vehicle at a speed exceeding the posted speed 26 limit within a special event zone established in accordance with this section. 27 (f) A person convicted of a violation of subsection (e) of this section is subject to a 28 fine not exceeding \$1,000. 29 21–1132.

- 3 (5) SKIDDING, SPINNING OF WHEELS, OR CAUSING EXCESSIVE NOISE 4 UNDER § 21–1117 OF THIS TITLE.
- 5 (F) (1) A PERSON CONVICTED OF A VIOLATION OF SUBSECTION (E) OF THIS SECTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 60 DAYS OR A FINE NOT EXCEEDING \$1,000 OR BOTH.
- 8 (2) A PERSON CONVICTED OF A VIOLATION OF SUBSECTION (F) OF 9 THIS SECTION IS SUBJECT TO A FINE NOT EXCEEDING \$1,000.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three–fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted.
