A BILL

To amend the Homeland Security Act of 2002 to enhance information sharing in the Department of Homeland Security State, Local, and Regional Fusion Center Initiative, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Improving Fusion Cen-*
5 *ters’ Access to Information Act”.*

6 **SEC. 2. ENHANCED INFORMATION SHARING IN THE DE-**
7 **PARTMENT OF HOMELAND SECURITY STATE,**
8 **LOCAL, AND REGIONAL FUSION CENTER INI-**
9 **TIATIVE.**

10 *Subsection (b) of section 210A of the Homeland Secu-*
11 *rity Act of 2002 (6 U.S.C. 124h) is amended—*

12 *(1) in paragraph (2), by inserting before the*
13 *semicolon at the end the following: “and conduct out-*
14 *reach to such fusion centers to identify any gaps in*
15 *information sharing and consult with other Federal*
16 *agencies to develop methods to address such gaps, as*
17 *appropriate”;*

18 *(2) by redesignating paragraphs (3) through (12)*
19 *as paragraphs (4) through (13), respectively; and*

20 *(3) by inserting after paragraph (2) the fol-*
21 *lowing new paragraph:*

22 *“(3) identify Federal databases and datasets, in-*
23 *cluding databases and datasets used, operated, or*
24 *managed by Department components, the Federal Bu-*
25 *reau of Investigation, and the Department of the*

1 *Treasury, that are appropriate, in accordance with*
2 *Federal laws and policies, to address any gaps identi-*
3 *fied pursuant to paragraph (2), for inclusion in the*
4 *information sharing environment and coordinate with*
5 *the appropriate Federal agency to deploy or access*
6 *such databases and datasets;”.*
