# SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

16 (a) (1) After the initial issuance of capital stock by a commercial bank, each of 17 its directors shall own in good faith and of record unencumbered shares of the capital stock 18 of:

19 (i) The commercial bank; or

20 (ii) A corporation that owns more than 80 percent of the capital stock 21 of the commercial bank.

22 (2) The unencumbered capital stock owned by the director shall be in the 23 amount of at least:
