- 7 (a) FAIR HOUSING ACT.—The Fair Housing Act (42
- 8 U.S.C. 3601 et seq.) is amended—

(1) in section 802, by adding at the end the fol lowing:

3 "(p) 'Race', 'color', 'religion', 'sex' (including sexual
4 orientation and gender identity), 'handicap', 'familial sta5 tus', or 'national origin', used with respect to an indi6 vidual, includes—

"(1) the race, color, religion, sex (including sexual orientation and gender identity), handicap, familial status, or national origin, respectively, of another person with whom the individual is associated
or has been associated; and

"(2) a perception or belief, even if inaccurate,
concerning the race, color, religion, sex (including
sexual orientation and gender identity), handicap,
familial status, or national origin, respectively, of the
individual.

"(q) 'Gender identity' means the gender-related identity, appearance, or mannerisms or other gender-related
characteristics of an individual, without regard to the individual's designated sex at birth.

21 "(r) 'Sexual orientation' means homosexuality, het22 erosexuality, or bisexuality.";

(2) in section 804, by inserting "(including sexual orientation and gender identity)" after "sex"
each place that term appears;

(3) in section 805, by inserting "(including sex-1 2 ual orientation and gender identity)" after "sex" 3 each place that term appears; (4) in section 806, by inserting "(including sex-4 ual orientation and gender identity)" after "sex" 5 6 each place that term appears; and 7 (5) in section 808(e)(6), by inserting "(including sexual orientation and gender identity)" after 8 "sex". 9 10 (b) PREVENTION OF INTIMIDATION IN FAIR HOUS-ING CASES.—Section 901 of the Civil Rights Act of 1968 11 12 (42 U.S.C. 3631) is amended by inserting "(including sex-13 ual orientation (as such term is defined in section 802 of 14 this Act) and gender identity (as such term is defined in section 802 of this Act))" after "sex" each place that term 15 16 appears.
