- 14 (a) Guidelines Required.—The Secretary of De-
- 15 fense shall develop guidelines regarding the use by the
- 16 Secretaries of the military departments and the Secretary
- 17 of Veterans Affairs of unofficial sources of information,
- 18 including eyewitness statements, to determine the eligi-
- 19 bility of a member or former member of the Armed Forces
- 20 for benefits and decorations when the service records of
- 21 the member are incomplete because of damage to the
- 22 records as a result of the 1973 fire at the National Per-
- 23 sonnel Records Center in St. Louis, Missouri, or any sub-
- 24 sequent incident while the records were in the possession
- 25 of the Department of Defense.

- 1 (b) Consultation.—The Secretary of Defense shall
- 2 prepare the guidelines in consultation with the Secretary
- 3 of Veterans Affairs, with respect to veterans benefits
- 4 under title 38, United States Code, whose eligibility deter-
- 5 minations depend on the use of service records maintained
- 6 by the Department of Defense.
- 7 (c) Time for Completion.—The Secretary of De-
- 8 fense shall complete development of the guidelines not
- 9 later than one year after the date of the enactment of this
- 10 Act.
