1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "Major Richard Star3 Act".

SEC. 2. ELIGIBILITY OF DISABILITY RETIREES WITH FEWER 4 5 THAN 20 YEARS OF SERVICE AND A COMBAT-6 **RELATED DISABILITY FOR CONCURRENT RE-**7 CEIPT OF VETERANS' DISABILITY COMPENSA-8 TION AND RETIRED PAY. 9 (a) CONCURRENT RECEIPT IN CONNECTION WITH CSRC.—Section 1413a(b)(3)(B) of title 10, United States 10 Code, is amended by striking "creditable service," and all 11 that follows and inserting the following: "creditable serv-12

(b) CONCURRENT RECEIPT GENERALLY.—Section
1414(b)(2) of title 10, United States Code, is amended
by striking "Subsection (a)" and all that follows and inserting the following: "Subsection (a)—

23 "(A) applies to a member described in
24 paragraph (1) of that subsection who is retired
25 under chapter 61 of this title with less than 20
26 years of service otherwise creditable under

1 chapter 1405 of this title, or with less than 20 2 years of service computed under section 12732 3 of this title, at the time of the member's retire-4 ment if the member has a combat-related dis-5 ability (as that term is defined in section 6 1413a(e) of this title), except that in the appli-7 cation of subsection (a) to such a member, any 8 reference in that subsection to a qualifying 9 service-connected disability shall be deemed to 10 be a reference to that combat-related disability; 11 but "(B) does not apply to any member so re-12 13 tired if the member does not have a combat-re-14 lated disability.". 15 (c) TECHNICAL AND CONFORMING AMENDMENTS.— 16 (1) Amendments reflecting end of con-17 CURRENT RECEIPT PHASE-IN PERIOD.—Section 18 1414 of title 10, United States Code, is further 19 amended-20 (A) in subsection (a)(1)— (i) by striking the second sentence; 21 22 and 23 (ii) by striking subparagraphs (A) and (B); 24

18	(d) EFFECTIVE DATE.—The amendments made by
19	this section shall take effect on the first day of the first
20	month beginning after the date of the enactment of this
21	Act and shall apply to payments for months beginning on
22	or after that date.
