3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Gun Violence Research

5 Act of 2017".

1 SEC. 2. FINDINGS.

3	(1) As of December 4, 2017, there have been
4	56,825 incidents of gun violence in the United
5	States in 2017.
6	(2) As of December 4, 2017, there have been
7	14,319 deaths related to gun violence in the United
8	States in 2017.

3 "SEC. 210. None of the funds made available in this 4 title may be used, in whole or in part, to advocate or pro-5 mote gun control. Nothing in this section shall be con-6 strued to limit funding for the conduct or support of re-7 search on mental health, gun violence, and how they inter-8 sect.".

9 SEC. 4. REPORT ON EFFECTS OF GUN VIOLENCE ON PUB10 LIC HEALTH.

11 Not later than one year after the date of the enact-12 ment of this Act, and annually thereafter, the Surgeon 13 General of the Public Health Service shall submit to Con-14 gress a report on the effects on public health, including 15 mental health, of gun violence in the United States during 16 the preceding year, and the status of actions taken to ad-17 dress such effects.

TAL HEALTH IN MINORITY COMMUNITIES.
