A BILL ENTITLED

1 AN ACT concerning

Vehicle Laws - Registration Plates

3 FOR the purpose of requiring the Motor Vehicle Administration to issue a single 4 registration plate to all classes of vehicles; providing for the method of attachment 5 of the registration plate; making certain conforming changes, a certain stylistic 6 change, and a certain technical correction; requiring the publisher of the Annotated 7 Code of Maryland, in consultation with and subject to the approval of the 8 Department of Legislative Services, to make certain corrections and to describe any 9 corrections made in an editor's note following the section affected; prohibiting persons who are issued a Class L (historic) registration plate from violating the terms 10 11 of issuance; providing for the issuance of a warning for a first violation of a certain 12 provision of this Act; and generally relating to vehicle registration plates.

- 23 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

- 2 (3) The Administration shall:
- 3 (i) Approve a sticker design option that complies with paragraph (2) 4 of this subsection; and
- 5 (ii) Offer to each vehicle owner applying for A new or replacement 6 registration [plates] PLATE under this title the option to select a sticker that displays the 7 owner's county of residence.
- 8 (4) In addition to the annual registration fee otherwise required under this 9 title, the Administration may charge a fee, not to exceed its costs, for issuing or replacing 10 the county sticker offered under this subsection.
- 11 (5) A vehicle owner may not display stickers that show a county name other 12 than the owner's county of residence.
- 13 (6) A county sticker issued under this subsection may not be placed on a 14 special registration plate or a commemorative registration plate issued under Subtitle 6 of 15 this title.
- 16 (d) Registration plates may be reflectorized and shall be manufactured of a 17 material warranted to have a durability of at least 5 years. However, prior to registration 18 plates being reflectorized, the Administration shall obtain approval of the General 19 Assembly through a budget item.
- 20 (e) (1) During subsequent registration years, the Administrator may order the continued use of registration plates that are valid during any current registration year, 22 and, after so doing, the Administrator shall issue, at the time a vehicle's registration is 23 renewed, a validation tab to evidence payment of the vehicle's annual registration fee.
- 24 (2) The tab shall be displayed on the [plates] PLATE of the vehicle in the 25 manner that the Administrator requires.
- 26 (3) The Administrator from time to time shall evaluate the condition of 27 registration plates issued under this title and may provide for the manufacture and 28 issuance of new registration plates. These new registration plates shall be issued and 29 subsequently validated in the manner required by this subtitle.
- 30 (f) Notwithstanding the provisions of subsection (d) of this section, the 31 Administration may issue reflectorized registration plates under §§ 13–618 and 32 13–619 of this title.
- 33 (g) The dimensions of a registration plate issued for a Class D (motorcycle) vehicle shall be 7 inches wide by 4 inches high.

- 1 (h) A registration plate that is required to be returned to the Administration may 2 be returned through the mail. 3 13–411. 4 On a vehicle for which two registration plates are required, one plate shall be 5 attached on the front and the other on the rear of the vehicle. On a vehicle for which one registration plate is required, the THE 6 (b) **REGISTRATION** plate shall be attached on the: 7 8 (1) Front of the vehicle for a Class F (tractor) vehicle; and 9 (2)Rear of the vehicle for every other vehicle. [(c)] **(B)** 10 At all times, [each] **THE** registration plate shall be: 11 (1) Maintained free from foreign materials, including A registration plate 12 [covers] COVER as defined in § 13-411.1 of this subtitle, and in a condition to be clearly 13 legible; and Securely fastened to the vehicle for which it is issued: 14 (2)15 (i) In a horizontal position; 16 In a manner that prevents the plate from swinging; and (ii) 17 In a place and position to be clearly visible. (iii) 18 Except as otherwise expressly permitted by the Maryland Vehicle Law, 19 as to any vehicle required to be registered under this title, a person may not drive the 20vehicle on any highway in this State, unless there is attached to the vehicle and displayed 21on it, as required in this title: 22A registration plate [or plates] issued for the vehicle by the (1) 23Administration for the current registration period; and 24(2)Any validation tab issued for the vehicle under this subtitle. 25 [(e)] **(D)** Except as otherwise expressly permitted by the Maryland Vehicle Law, as to any vehicle required to be registered under this title, the owner of the vehicle may not 2627permit the vehicle to be driven on any highway in this State, unless there is attached to 28and displayed on the vehicle, as required in this title:
- 29 (1) A registration plate [or plates] issued by the Administration for the 30 current registration period; and

- 1 (2) Any validation tab issued for the vehicle under this subtitle.
- 2 **[**(f)**] (E)** Except as otherwise expressly permitted by the Maryland Vehicle Law, a vehicle used or driven in this State may not display on either its front or rear any expired registration plate issued by any state.
 - [(g)] **(F)** Except as otherwise expressly permitted by the Maryland Vehicle Law, a person may not display or permit to be displayed on any vehicle used or driven in this State any registration plate issued for another vehicle or to a person other than the owner of the vehicle.
- 9 [(h)] (G) A vehicle registered as a historic or antique vehicle (Class L) in (1) 10 this State or in another state, when used or driven in this State, may display vintage registration plates as an indication of the historic or antique nature of the vehicle. Except 11 12 as provided in paragraph (2) of this subsection, the place on the vehicle provided for the 13 display of A registration [plates] PLATE may only be used for the display of THE current registration [plates] PLATE in accordance with subsections (a) [through (c)] AND (B) of 14 15 this section, and any vintage registration plates which are used shall be displayed 16 elsewhere on the vehicle.
- 17 (2) If the Administration authorizes the display of vintage registration 18 plates in lieu of **THE** current registration [plates] **PLATE**, as provided in § 13–936.1 of this 19 title, the vintage registration plates shall be displayed as required under subsections (a) 20 [through (c)] **AND** (B) of this section. However, the current registration [plates] **PLATE** 21 shall be kept in the vehicle at all times.
- [(i)] (H) It is the duty of every police officer to report to the Administration all vehicles operated in violation of this section. The Administration shall verify whether the owner of a reported vehicle has complied with this section.

- 26 (I) (1) AS TO ANY CLASS L (HISTORIC) VEHICLE REGISTRATION PLATE 27 ISSUED TO A PERSON UNDER § 13–936 OF THIS TITLE, THE PERSON MAY NOT 28 KNOWINGLY VIOLATE THE TERMS OF THE ISSUANCE.
- 29 (2) A FIRST VIOLATION OF THIS SUBSECTION SHALL BE ENFORCED BY 30 THE ISSUANCE OF A WARNING.
 - SECTION 2. AND BE IT FURTHER ENACTED, That any reference in the Annotated Code of Maryland to multiple registration plates rendered obsolete by this Act shall be corrected by the publisher of the Annotated Code of Maryland, in consultation with and subject to the approval of the Department of Legislative Services, with no further action required by the General Assembly. The publisher shall adequately describe any correction made under this section in an editor's note following the section affected.

SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2020.
