Foreign Corporations – Resident Agents – State Department of Assessments and Taxation

4 FOR the purpose of authorizing a foreign corporation to certify that the State Department of Assessments and Taxation is the corporation's resident agent when registering $\mathbf{5}$ 6 with the Department; authorizing a foreign corporation to certify that the 7 Department is the corporation's resident agent when qualifying with the 8 Department; authorizing the Department to act as a resident agent for a foreign 9 corporation that does business in the State without a resident agent or with a 10 resident agent who cannot be found or served with the exercise of reasonable diligence; making a stylistic change; and generally relating to resident agents of 11 12foreign corporations.

[(d)] (E) A foreign corporation and its resident agent may change the resident agent, his address, or the address of a principal office of the corporation in the same manner as provided for a Maryland corporation under § 2–108 of this article.
