The House Committee on Transportation offers the following substitute to SB 219:

## A BILL TO BE ENTITLED AN ACT

1 To amend Title 40 of the Official Code of Georgia Annotated, relating to motor vehicles, so 2 as to provide for definitions; to exempt persons operating a fully autonomous motor vehicle 3 with the automated driving system engaged from the requirement to hold a driver's license; 4 to provide for satisfaction of requirement to notify law enforcement in certain instances of accidents by fully autonomous motor vehicles; to provide for certain equipment and 5 insurance requirements for fully autonomous motor vehicles; to provide for registration 6 7 requirements for such vehicles; to provide for exemptions from seat belt requirements; to 8 provide for applicability; to provide for limitations on adoption of certain rules and 9 regulations; to provide for related matters; to repeal conflicting laws; and for other purposes.

10 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

## 11 **SECTION 1.** 12 Title 40 of the Official Code of Georgia Annotated, relating to motor vehicles, is amended 13 in Code Section 40-1-1, relating to definitions, by revising paragraphs (15.2), (15.3), (17.2), 14 and (38) and adding new paragraphs as follows: 15 "(5.1) 'Automated driving system' means the hardware and software that are collectively 16 capable of performing the entire dynamic driving task on a sustained basis, regardless of 17 whether it is limited to a specific operational design domain." 18 "(15.2) 'Dynamic driving task' means all of the real-time operational and tactical 19 functions required to operate a vehicle in on-road traffic, excluding the strategic functions 20 such as trip scheduling and selection of destinations and waypoints, including without 21 limitation: 22 (A) Lateral vehicle motion control via steering; 23 (B) Longitudinal motion control via acceleration and deceleration; 24 (C) Monitoring the driving environment via object and event detection, recognition, 25 classification, and response preparation; 26 (D) Object and event response execution;

- 27 (E) Maneuver planning; and (F) Enhancing conspicuity via lighting, signaling, and gesturing. 28 29 (15.3) 'Electric assisted bicycle' means a device with two or three wheels which has a 30 saddle and fully operative pedals for human propulsion and also has an electric motor. For such a device to be considered an electric assisted bicycle, it shall meet the 31 32 requirements of the Federal Motor Vehicle Safety Standards, as set forth in 49 C.F.R. 33 Section 571, et seq., and shall operate in such a manner that the electric motor disengages or ceases to function when the brakes are applied. The electric motor in an electric 34 assisted bicycle shall: 35 36 (A) Have a power output of not more than 1,000 watts;
- 37 (B) Be incapable of propelling the device at a speed of more than 20 miles per hour on38 level ground; and
- 39 (C) Be incapable of further increasing the speed of the device when human power40 alone is used to propel the device at or more than 20 miles per hour.
- 41 (15.3)(15.4) 'Electric personal assistive mobility device' or 'EPAMD' means a
  42 self-balancing, two nontandem wheeled device designed to transport only one person and
  43 having an electric propulsion system with average power of 750 watts (1 horsepower) and
  44 a maximum speed of less than 20 miles per hour on a paved level surface when powered
  45 solely by such propulsion system and ridden by an operator who weighs 170 pounds."
- 46 "(17.2) <u>'Fully autonomous vehicle' means a motor vehicle equipped with an automated</u>
  47 driving system that has the capability to perform all aspects of the dynamic driving task
  48 without a human driver within a limited or unlimited operational design domain and will
  49 not at any time request that a driver assume any portion of the dynamic driving task when
  50 the automated driving system is operating within its operational design domain.
- 51 (17.3) 'Golf car' or 'golf cart' means any motorized vehicle designed for the purpose and 52 exclusive use of conveying one or more persons and equipment to play the game of golf in an area designated as a golf course. For such a vehicle to be considered a golf car or 53 54 golf cart, its average speed shall be less than 15 miles per hour (24 kilometers per hour) 55 on a level road surface with a 0.5% grade (0.3 degrees degree) comprising a straight 56 course composed of a concrete or asphalt surface that is dry and free from loose material 57 or surface contamination with a minimum coefficient of friction of 0.8 between tire and surface." 58
- 59 "(27.1) 'Minimal risk condition' means a low-risk operating mode in which a fully
  60 autonomous vehicle operating without a human driver achieves a reasonably safe state,
  61 such as bringing the vehicle to a complete stop, upon experiencing a failure of the
  62 vehicle's automated driving system that renders the vehicle unable to perform the entire
  63 dynamic driving task."

64 "(37.1) 'Operational design domain' means a description of the specific operating
65 domains in which an automated driving system is designed to effectively operate,
66 including but not limited to geographic limitations, roadway types, speed range, and
67 environmental conditions such as weather and limited visibility.
68 (38) 'Operator' means any person who drives or is in actual physical control of a motor
69 vehicle or who causes a fully autonomous vehicle to move or travel with the automated

70 <u>driving system engaged</u>."

## **SECTION 2.**

Said title is further amended in Code Section 40-5-21, relating to exemptions to driver's
license requirement, by revising paragraphs (11) and (12) and adding a new paragraph to
subsection (a) as follows:

"(11) Any resident who is 15 years of age or over while taking actual in-car training in 75 76 a training vehicle other than a commercial motor vehicle under the direct personal 77 supervision of a driving instructor when such driving instructor and training vehicle are 78 licensed by the department in accordance with the provisions of Chapter 13 of Title 43, 79 'The Driver Training School License Act.' As used in the previous sentence, the term 80 'commercial motor vehicle' shall have the meaning specified in Code Section 40-5-142. 81 All vehicles utilized for the in-car training authorized under this paragraph shall be 82 equipped with dual controlled brakes and shall be marked with signs in accordance with 83 the rules of the department clearly identifying such vehicles as training cars belonging 84 to a licensed driving school. A driving instructor shall test the eyesight of any unlicensed 85 person who will be receiving actual in-car training prior to commencement of such training, and no unlicensed driver shall receive in-car training unless such person has at 86 87 least the visual acuity and horizontal field of vision as is required for issuance of a 88 driver's license in subsection (c) of Code Section 40-5-27; and

90 (A) On any way publicly maintained for the use of personal transportation vehicles by
91 the public and no other types of motor vehicles in accordance with a local ordinance
92 adopted pursuant to Part 3 or 6 of Article 13 of Chapter 6 of this title; or

- (B) When crossing a street or highway used by other types of motor vehicles at a
  location designated for such crossing pursuant to subsection (d) of Code
  Section 40-6-331 or pursuant to a PTV plan authorized by a local authority as described
  in Part 6 of Article 13 of Chapter 6 of this title; and
- 97 (13) A fully autonomous vehicle with the automated driving system engaged or the
- 98 operator of a fully autonomous vehicle with the automated driving system engaged."

- 134 (b) It shall be the responsibility of the occupants of a fully autonomous vehicle to comply
- 135 with the requirements of Code Sections 40-8-76 and 40-8-76.1 regarding the use of safety
- 136 <u>belts and child passenger restraining systems.</u>
- 137 (c) Unless otherwise provided in this Code section, fully autonomous vehicles, automated
- 138 <u>driving systems, and any commercial use or operation of fully autonomous vehicles shall</u>
- 139 be governed by this Code section, Code Sections 40-1-1 and 40-5-21, Chapter 6 of this
- 140 <u>title, and this chapter notwithstanding any other provision of law to the contrary. No rules</u>
- 141 <u>or regulations relative to the operation of fully autonomous vehicles or automated driving</u>
- 142 systems shall be adopted which limit the authority to operate such vehicles or systems
- 143 <u>conferred by this Code section.</u>"
