# **A BILL**

To amend the Balanced Budget and Emergency Deficit Control Act of 1985 and to establish a congressional budget for fiscal year 2020.

1 *Be it enacted by the Senate and House of Representa-*  
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Investing for the Peo-  
 5 ple Act of 2019”.

6 **TITLE I—BUDGET**  
 7 **ENFORCEMENT**

8 **SEC. 101. AMENDMENTS TO THE BALANCED BUDGET AND**  
 9 **EMERGENCY DEFICIT CONTROL ACT OF 1985.**

10 (a) REVISED DISCRETIONARY SPENDING LIMITS.—  
 11 Section 251(c) of the Balanced Budget and Emergency  
 12 Deficit Control Act of 1985 (2 U.S.C. 901(c)) is amended  
 13 by striking paragraphs (7) and (8) and inserting the fol-  
 14 lowing:

15 “(7) for fiscal year 2020—

16 “(A) for the revised security category,  
 17 \$664,000,000,000 in new budget authority; and

18 “(B) for the revised nonsecurity category,  
 19 \$631,018,000,000 in new budget authority; and

20 “(8) for fiscal year 2021—

21 “(A) for the revised security category,  
 22 \$680,119,000,000; and

23 “(B) for the revised nonsecurity category,  
 24 \$646,056,000,000;”.

1 (b) OVERSEAS CONTINGENCY OPERATIONS/GLOBAL  
2 WAR ON TERRORISM ADJUSTMENT LIMIT.—Section  
3 251(b)(2) of the Balanced Budget and Emergency Deficit  
4 Control Act of 1985 (2 U.S.C. 901(b)(2)) is amended in  
5 subparagraph (A) by inserting before the period at the end  
6 the following: “, except that the adjustment for Overseas  
7 Contingency Operations/Global War on Terrorism for fis-  
8 cal year 2020 or any subsequent fiscal year shall not ex-  
9 ceed \$69,000,000,000 for the revised security category or  
10 \$8,000,000,000 for the revised nonsecurity category”.

11 (c) NEW ADJUSTMENTS FOR THE INTERNAL REV-  
12 ENUE SERVICE AND THE U.S. CENSUS FOR 2020.—Sec-  
13 tion 251(b)(2) of the Balanced Budget and Emergency  
14 Deficit Control Act of 1985 (2 U.S.C. 901(b)(2)) is  
15 amended by adding at the end the following two new sub-  
16 paragraphs:

17 “(G) INTERNAL REVENUE SERVICE TAX  
18 ENFORCEMENT.—

19 “(i) IN GENERAL.—If a bill or joint  
20 resolution making appropriations for a fis-  
21 cal year is enacted that specifies an  
22 amount in the Enforcement account and  
23 the Operations Support account for tax en-  
24 forcement activities, including tax compli-  
25 ance to address the Federal tax gap, of the

1 Internal Revenue Service of the Depart-  
2 ment of the Treasury, then the adjustment  
3 for that fiscal year shall be the additional  
4 new budget authority provided in that Act  
5 for such purpose for that fiscal year, but  
6 shall not exceed—

7 “(I) for fiscal year 2020,  
8 \$400,000,000; and

9 “(II) for fiscal year 2021,  
10 \$750,000,000.

11 “(ii) DEFINITION.—As used in this  
12 subparagraph, the term ‘additional new  
13 budget authority’ means the amount pro-  
14 vided for a fiscal year, in excess of  
15 \$8,584,000,000, in an appropriation Act  
16 and specified for tax enforcement activi-  
17 ties, including tax compliance to address  
18 the Federal tax gap, of the Internal Rev-  
19 enue Service.

20 “(H) THE 2020 CENSUS.—

21 “(i) IN GENERAL.—If a bill or joint  
22 resolution making appropriations for fiscal  
23 year 2020 is enacted that specifies an  
24 amount for the 2020 Census in the Peri-  
25 odic Censuses and Programs account of

1 the Bureau of the Census of the Depart-  
2 ment of Commerce, then the adjustment  
3 for that fiscal year shall be the new budget  
4 authority provided in that Act for such  
5 purpose for fiscal year 2020, but shall not  
6 exceed \$7,500,000,000.

7 “(ii) DEFINITION.—As used in this  
8 subparagraph, the term ‘new budget au-  
9 thority’ means the amount provided for fis-  
10 cal year 2020 in an appropriation Act and  
11 specified to pay for expenses associated  
12 with 2020 Census operations.”.

13 (d) DIRECT SPENDING ADJUSTMENTS FOR FISCAL  
14 YEARS 2020 AND 2021.—Section 251A of the Balanced  
15 Budget and Emergency Deficit Control Act of 1985 (2  
16 U.S.C. 901a), is amended—

17 (1) in paragraph (5)(B), in the matter pre-  
18 ceding clause (i), by striking “and (12)” and insert-  
19 ing “, (12), and (13)”; and

20 (2) by adding at the end the following:

21 “(13) IMPLEMENTING DIRECT SPENDING RE-  
22 Ductions FOR FISCAL YEARS 2020 AND 2021.—(A)  
23 OMB shall make the calculations necessary to imple-  
24 ment the direct spending reductions calculated pur-  
25 suant to paragraphs (3) and (4) without regard to

1 the amendment made to section 251(c) revising the  
 2 discretionary spending limits for fiscal years 2020  
 3 and 2021 by the Investing for the People Act of  
 4 2019.

5 “(B) Paragraph (5)(B) shall not be imple-  
 6 mented for fiscal years 2020 and 2021.”.

## 7 **TITLE II—ESTABLISHING A** 8 **CONGRESSIONAL BUDGET**

### 9 **SEC. 201. FISCAL YEAR 2020 BUDGET RESOLUTION.**

10 (a) FISCAL YEAR 2020.—For the purpose of enforce-  
 11 ing the Congressional Budget Act of 1974 for fiscal year  
 12 2020, the allocations, aggregates, and levels provided for  
 13 in subsection (b) shall apply in the House of Representa-  
 14 tives in the same manner as for a concurrent resolution  
 15 on the budget for fiscal year 2020 with appropriate budg-  
 16 etary levels for fiscal year 2020 and for fiscal years 2021  
 17 through 2029.

18 (b) COMMITTEE ALLOCATIONS, AGGREGATES, AND  
 19 LEVELS.—In the House of Representatives, the Chair of  
 20 the Committee on the Budget shall submit a statement  
 21 for publication in the Congressional Record as soon as  
 22 practicable, containing—

23 (1) for the Committee on Appropriations, com-  
 24 mittee allocations for fiscal year 2020 consistent  
 25 with discretionary spending limits set forth in sec-

1       tion 251(c)(7) of the Balanced Budget and Emer-  
2       gency Deficit Control Act of 1985, as amended by  
3       this Act, and the outlays flowing therefrom, and  
4       committee allocations for fiscal year 2020 for cur-  
5       rent law mandatory budget authority and outlays,  
6       for the purpose of enforcing section 302 of the Con-  
7       gressional Budget Act of 1974;

8               (2) for all committees of that House other than  
9       the Committee on Appropriations, committee alloca-  
10      tions for fiscal year 2020 and for the period of fiscal  
11      years 2020 through 2029 consistent with the most  
12      recent baseline of the Congressional Budget Office,  
13      as adjusted, to the extent practicable, for the budg-  
14      etary effects of any provision of law enacted during  
15      the period beginning on the date such baseline is  
16      issued and ending on the date of submission of such  
17      statement, for the purpose of enforcing section 302  
18      of the Congressional Budget Act of 1974;

19             (3) aggregate spending levels for fiscal year  
20      2020 in accordance with the allocations established  
21      under paragraphs (1) and (2), for the purpose of en-  
22      forcing section 311 of the Congressional Budget Act  
23      of 1974; and

24             (4) aggregate revenue levels for fiscal year 2020  
25      and for the period of fiscal years 2020 through 2029



1 consistent with the most recent baseline of the Con-  
2 gressional Budget Office, as adjusted, to the extent  
3 practicable, for the budgetary effects of any provi-  
4 sion of law enacted during the period beginning on  
5 the date such baseline is issued and ending on the  
6 date of submission of such statement, for the pur-  
7 pose of enforcing section 311 of the Congressional  
8 Budget Act of 1974.

9 (c) ADDITIONAL MATTER.—The statement referred  
10 to in subsection (b) may also include for fiscal year 2020,  
11 the matter contained in the provisions referred to in sub-  
12 section (e).

13 (d) ADJUSTMENTS.—The Chair of the Committee on  
14 the Budget of the House of Representatives may adjust  
15 the allocations, aggregates, and other budgetary levels in-  
16 cluded in the statement referred to in subsection (b)—

17 (1) to reflect changes resulting from the Con-  
18 gressional Budget Office’s updates to its baseline for  
19 fiscal years 2020 through 2029; or

20 (2) for any bill, joint resolution, amendment, or  
21 conference report by the amounts provided in such  
22 measure if such measure would not increase the def-  
23 icit for either of the following time periods: fiscal  
24 year 2020 to fiscal year 2024 or fiscal year 2020 to  
25 fiscal year 2029.

1       (e) APPLICATION.—Upon submission of the state-  
2 ment referred to in subsection (b), all references to alloca-  
3 tions, aggregates, or other appropriate levels in “this con-  
4 current resolution” in sections 5201, 5202, and 5203 of  
5 the House Concurrent Resolution 71 (115th Congress),  
6 specified in section 30104(f)(1) of the Bipartisan Budget  
7 Act of 2018, and continued in effect by section 103(m)  
8 of House Resolution 6 (116th Congress), shall be treated  
9 for all purposes in the House of Representatives as ref-  
10 erences to the allocations, aggregates, or other appropriate  
11 levels contained in the statement referred to in subsection  
12 (b), as adjusted in accordance with this section or any  
13 other Act.

14 **SEC. 202. LIMITATION ON ADVANCE APPROPRIATIONS.**

15       (a) IN GENERAL.—Except as provided in subsection  
16 (b), any general appropriation bill or bill or joint resolu-  
17 tion continuing appropriations, or amendment thereto or  
18 conference report thereon, may not provide an advance ap-  
19 propriation.

20       (b) EXCEPTIONS.—An advance appropriation may be  
21 provided for programs, activities or accounts identified in  
22 lists submitted for printing in the Congressional Record  
23 by the Chair of the Committee on the Budget—

24               (1) for fiscal year 2021, under the heading “Ac-  
25       counts Identified for Advance Appropriations” in an

1 aggregate amount not to exceed \$28,852,000,000 in  
2 new budget authority, and for fiscal year 2022, ac-  
3 counts separately identified under the same heading;  
4 and

5 (2) for fiscal year 2021, under the heading  
6 “Veterans Accounts Identified for Advance Appro-  
7 priations” in an aggregate amount not to exceed  
8 \$87,636,650,000 in new budget authority.

9 (c) DEFINITION.—The term “advance appropriation”  
10 means any new discretionary budget authority provided in  
11 a general appropriation bill or bill or joint resolution con-  
12 tinuing appropriations for fiscal year 2020, or any amend-  
13 ment thereto or conference report thereon, that first be-  
14 comes available following fiscal year 2020.

15 **SEC. 203. EXERCISE OF RULEMAKING POWERS.**

16 Sections 201 and 202 are enacted by the House of  
17 Representatives—

18 (1) as an exercise of the rulemaking power of  
19 the House of Representatives, and as such they shall  
20 be considered as part of the rules of the House of  
21 Representatives, and such rules shall supersede  
22 other rules only to the extent that they are incon-  
23 sistent therewith; and

24 (2) with full recognition of the constitutional  
25 right of the House of Representatives to change

- 1       such rules at any time, in the same manner, and to
- 2       the same extent as in the case of any other rule of
- 3       the House of Representatives.
