## A BILL

To direct the Secretary of the Army to expedite completion of the reports for certain projects included in the Comprehensive Everglades Restoration Plan, and for other purposes.

- 3 SECTION 1. SHORT TITLE; PURPOSES.
- 4 (a) Short Title.—This Act may be cited as the
- 5 "Everglades Flow Increases Rely on Storage and Treat-
- 6 ment Act" or the "Everglades FIRST Act".
- 7 (b) Purposes.—The purposes of this Act include—

1	(1) improving surface water reservoir storage
