## RESOLUTION

Requesting the President, and directing the Secretary of Homeland Security, to transmit to the House of Representatives copies of all documents in their possession referring or relating to certain aspects of border policies of the United States.

1       *Resolved*, That the House of Representatives requests  
2 the President, and directs the Secretary of Homeland Se-  
3 curity, to transmit to the House of Representatives, not  
4 later than 14 days after the date of the adoption of this  
5 resolution, copies of all documents, memoranda, analytical  
6 products, advisory legal opinions, notes, reports, briefing  
7 materials, intelligence assessments, audio recordings,  
8 records (including telephone and electronic mail records),  
9 correspondence, communications, and other materials,  
10 both classified and unclassified, in the possession of the  
11 President or the Secretary, respectively, as of the date of  
12 adoption of this resolution that refer or relate to—

13           (1) Department of Homeland Security policies  
14       implemented and data collected regarding individ-  
15       uals who, from January 20, 2021, until such date of  
16       adoption, have arrived at the southwest border of

1 the United States with the intent to enter the  
2 United States, including—

3 (A) the total number of encounters re-  
4 ported by U.S. Customs and Border Protection  
5 (CBP) personnel, on a monthly basis;

6 (B) the total number of such encounters  
7 reported by CBP personnel, on a monthly basis,  
8 of individuals—

9 (i) who had previously been encoun-  
10 tered attempting to cross the southwest  
11 border;

12 (ii) attempting to cross the Southwest  
13 border as part of a family unit;

14 (iii) who are single adult males at-  
15 tempting to cross the southwest border;

16 (iv) who are single adult females at-  
17 tempting to cross the southwest border;

18 (v) who are unaccompanied minor  
19 children attempting to cross the southwest  
20 border; and

21 (vi) admitted into the United States  
22 after processing by CBP;

23 (C) the total number of such individuals  
24 who have reported to U.S. Immigration and  
25 Customs Enforcement (ICE) after previously

1 being admitted into the United States after  
2 such processing;

3 (D) the total number of unaccompanied  
4 minor children admitted into the United States  
5 after such processing and transferred to the  
6 custody of the Department of Health and  
7 Human Services;

8 (E) the total number of individuals en-  
9 countered by CBP personnel and denied admis-  
10 sion to the United States;

11 (F) potential explanations for changes in  
12 the number of encounters described in subpara-  
13 graph (B) from previous years;

14 (G) estimates of how many individuals  
15 were able to cross the border into the United  
16 States without being encountered by CBP per-  
17 sonnel, on a monthly basis;

18 (H) any analysis done prior to January 20,  
19 2021, regarding the potential consequences of  
20 reversing or suspending immigration policies  
21 implemented under the previous presidential ad-  
22 ministration;

23 (I) reimplementaion of the Migrant Pro-  
24 tection Protocols described in the Department  
25 of Homeland Security memorandum entitled

1 “Policy Guidance for Implementation of the Mi-  
2 grant Protection Protocols”, dated January 25,  
3 2019;

4 (J) guidance relating to the documentation  
5 required and accepted as valid identification for  
6 migrants traveling within the United States, in-  
7 cluding Transportation Security Administration  
8 policies regarding valid identification docu-  
9 mentation required for migrants to pass  
10 through airport security checkpoints;

11 (K) the use of authority under section 362  
12 of the Public Health Service Act (42 U.S.C.  
13 265; commonly and popularly referred to as  
14 “title 42 authority”) to prevent the spread of  
15 communicable diseases to suspend persons and  
16 property from the United States;

17 (L) processes, procedures, and guidance  
18 relating to COVID–19 for individuals encoun-  
19 tered along the southwest border, including re-  
20 quirements related to testing, quarantine peri-  
21 ods, and vaccinations; and

22 (M) deployment and use of new and exist-  
23 ing technology, including surveillance towers,  
24 ground sensors, cargo scanning equipment, and

1           drones, on the southwest border to support De-  
2           partment of Homeland Security operations;

3           (2) the total amounts of illicit narcotics, includ-  
4           ing fentanyl, seized by CBP, and any internal docu-  
5           mentation related to potential explanations for  
6           changes in seizure amounts from previous years;

7           (3) the treatment of unaccompanied minor chil-  
8           dren who, from January 20, 2021, until such date  
9           of adoption, have been encountered crossing the  
10          southwest border, including—

11                 (A) information regarding processes, proce-  
12                 dures, and guidance relating to such encoun-  
13                 ters;

14                 (B) the Department’s current screening  
15                 and vetting procedures to determine a migrant’s  
16                 age as well as if a migrant is an unaccompanied  
17                 child prior to transfer to the Department of  
18                 Health and Human Services, including—

19                         (i) instances in the past three cal-  
20                         endar years in which an adult migrant pos-  
21                         ing as an unaccompanied minor child  
22                         was—

23                                 (I) encountered at the southwest  
24                                 border; or

1 (II) detected residing in the  
2 United States; and

3 (ii) the Department's response to in-  
4 stances in which migrant adults posing as  
5 undocumented migrant children commit  
6 acts of violence or other crimes;

7 (C) information regarding transportation  
8 of unaccompanied minor children aboard United  
9 States Government-chartered and commercial  
10 flights departing from locations near or on the  
11 southwest border and flying to locations in the  
12 United States; and

13 (D) information regarding such flights ar-  
14 riving at Westchester County Airport;

15 (4) any activity within the Department to track  
16 transnational criminal organizations that have en-  
17 gaged in human trafficking along the southwest bor-  
18 der of the United States, including—

19 (A) any discussions, assessments, or pro-  
20 fessional opinions regarding the extent to which  
21 such transnational criminal organizations have  
22 profited from such human trafficking;

23 (B) any intelligence assessments, products,  
24 or activities of the Department regarding the  
25 regional activities of transnational criminal or-

1 organizations in Central and South America, in-  
2 cluding the role of such organizations in facili-  
3 tating the formation and movement of large  
4 groups of migrants traveling together to the  
5 southwest border;

6 (C) incidents in which Department per-  
7 sonnel interdicted criminals attempting to traf-  
8 fic migrants across the southwest border;

9 (D) incidents in which Department per-  
10 sonnel interdicted criminals attempting to traf-  
11 fic children across the southwest border;

12 (E) incidents in which Department per-  
13 sonnel or local law enforcement were involved or  
14 arrived on the scene of a traffic accident at or  
15 near the southwest border in which one of the  
16 vehicles involved was found to be involved in  
17 human trafficking; and

18 (F) communications with State and local  
19 law enforcement along the southwest border re-  
20 garding incidents of human trafficking, includ-  
21 ing child trafficking;

22 (5) incidents in which a child could not be lo-  
23 cated after being released into the United States  
24 pending a removal hearing with or to an accom-



1       panying adult claiming to be the legal guardian of  
2       such child;

3               (6) communications between the Department  
4       and the Government of Mexico regarding unaccom-  
5       panied migrant children crossing the southwest bor-  
6       der from January 20, 2021, until such date of adop-  
7       tion; and

8               (7) policies and procedures when children are  
9       interdicted at the southwest border and found to be  
10      trafficking illicit commodities.
