

- 1 (iii) If a claimant does not have "average weekly wages" to qualify 2 under the formula in Title 9, Subtitle 6 of the Labor and Employment Article, the award 3 shall be in an amount equal to the average of the maximum and minimum awards listed in 4 the applicable portion of that subtitle.
- 5 (2) An award for loss of earnings or support made under this subtitle may 6 be up to two—thirds of the victim's gross average wage, but may not be less than the amount 7 provided in paragraph (1) of this subsection.
- 8 (3) The parent or guardian of a victim who is a child and who resides with 9 the victim may be eligible for an award of up to 30 days of lost earnings as a result of caring 10 for the victim.
- 11 (4) An award for funeral expenses may not exceed \$5,000.
- 12 (5) Subject to the limitation under subsection (b)(3) of this section and § 11–812 of this subtitle, a person who is eligible for an award as the result of the death of a victim or psychological injury may be eligible, under the regulations that the Board adopts, to receive psychiatric, psychological, or mental health counseling.
- 16 (6) Subject to the limitation under subsection (b)(6) of this section and § 11–812 of this subtitle, a parent, child, or spouse of a victim who resides with the victim and who is eligible for an award as the result of the injury of a victim is eligible to receive psychiatric, psychological, or mental health counseling.
