A BILL

To repeal certain obsolete laws relating to Indians.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Repealing Existing
- 5 Substandard Provisions Encouraging Conciliation with
- 6 Tribes Act".
- 7 SEC. 2. REPEAL OF CERTAIN OBSOLETE LAWS RELATING
- 8 TO INDIANS.
