SENATE BILL NO. 1448

BY FINANCE COMMITTEE

AN ACT

RELATING TO THE APPROPRIATION TO THE DEPARTMENT OF COMMERCE; APPROPRIATING
ADDITIONAL MONEYS TO THE DEPARTMENT OF COMMERCE FOR FISCAL YEAR 2025;
REDUCING THE APPROPRIATION TO THE DEPARTMENT OF COMMERCE FOR FISCAL
YEAR 2025; PROVIDING REQUIREMENTS FOR BROADBAND FUNDING FROM THE IN-
FRASTRUCTURE INVESTMENT AND JOBS ACT; AND DECLARING AN EMERGENCY AND
PROVIDING AN EFFECTIVE DATE.

Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. In addition to any other appropriation provided by law,
there is hereby appropriated to the Department of Commerce the following
amounts to be expended according to the designated programs and expense
classes from the listed funds for the period July 1, 2024, through June 30,
2025:

25 SECTION 3. BROADBAND FUNDING FROM THE INFRASTRUCTURE INVESTMENT AND
26 JOBS ACT. It is the intent of the Legislature to provide approximately
27 \$588,000,000 of Infrastructure Investment and Jobs Act (IIJA) funding for
28 broadband to connect unserved and underserved households in Idaho until the
29 grant is complete. Funds for broadband grants are approved by the Idaho
30 Broadband Advisory Board and administered by the Idaho Office of Broadband.

31 SECTION 4. An emergency existing therefor, which emergency is hereby
32 declared to exist, this act shall be in full force and effect on and after
33 July 1, 2024.
