Mr. RATCLIFFE introduced the following bill; which was referred to the Committee on Agriculture

A BILL

To require the Secretary of Agriculture to transfer certain National Forest System land in the State of Texas.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Lake Fannin Convey-
- 5 ance Act".
- 6 SEC. 2. DEFINITIONS.
- 7 In this Act:
- 8 (1) COUNTY.—The term "County" means
- 9 Fannin County, Texas.

| 8 | (4) Secretary.—The term "Secretary" means |
| 9 | the Secretary of Agriculture, acting through the |
| 10 | Chief of the Forest Service. |
| 11 | SEC. 3. LAND CONVEYANCE. |
| 12 | (a) In General.—Subject to the terms and condi- |
| 13 | tions described in subsection (b), if the County submits |
| 14 | to the Secretary an offer to acquire the National Forest |
| 15 | System land for the fair market value, as determined by |
| 16 | the appraisal under subsection (c), the Secretary shall con- |
| 17 | vey the National Forest System land to the County. |
| 18 | (b) Terms and Conditions.—The conveyance |
| 19 | under subsection (a) shall be— |
| 20 | (1) subject to valid existing rights; |
| 21 | (2) made by quitclaim deed; and |
| 22 | (3) subject to any other terms and conditions |
| 23 | as the Secretary considers appropriate to protect the |
| 24 | interests of the United States. |
| 25 | (c) Appraisal.— |

| 1 | (1) In general.—Not later than 180 days |

| 2 | after the date of enactment of this Act, the Sec- |
| 3 | retary shall complete an appraisal to determine the |
| 4 | fair market value of the National Forest System |
| 5 | land. |
| 6 | (2) Standards.—The appraisal under para- |
| 7 | graph (1) shall be conducted in accordance with— |
| 8 | (A) the Uniform Appraisal Standards for |
| 9 | Federal Land Acquisitions; and |
| 10 | (B) the Uniform Standards of Professional |
| 11 | Appraisal Practice. |
| 12 | (d) Map.— |
| 13 | (1) AVAILABILITY OF MAP.—The map shall be |
| 14 | kept on file and available for public inspection in the |
| 15 | appropriate office of the Forest Service. |
| 16 | (2) Correction of Errors.—The Secretary |
| 17 | may correct minor errors in the map. |
| 18 | (e) Consideration.—As consideration for the con- |
| 19 | veyance under subsection (a), the County shall pay to the |
| 20 | Secretary an amount equal to the fair market value of the |
| 21 | National Forest System land, as determined by the ap- |
| 22 | praisal under subsection (c). |
| 23 | (f) Survey.—The exact acreage and legal description |
| 24 | of the National Forest System land to be conveyed under |

- 1 subsection (a) shall be determined by a survey satisfactory
- 2 to the Secretary and the County.
- 3 (g) Use.—As a condition of the conveyance under
- 4 subsection (a), the County shall agree to manage the land
- 5 conveyed under that subsection for public recreational
- 6 purposes.
- 7 (h) Costs of Conveyance.—As a condition of the
- 8 conveyance under subsection (a), the County shall pay to
- 9 the Secretary all costs associated with the conveyance, in-
- 10 cluding the cost of—
- 11 (1) the appraisal under subsection (c); and
- 12 (2) the survey under subsection (f).
