"Section 6.2. **Property Taxes.** The Town of Bermuda Run shall not increase its property tax rates in excess of fifteen cents (\$0.15) per one hundred dollars (\$100.00) of valuation without the <u>affirmative</u> vote <u>or consent</u> of a majority of the <u>residents qualified voters</u> of the Town <u>participating in the referendum. The referendum shall be held in accordance with G.S. 160A-209(f)."</u>

SECTION 2. This act is effective when it becomes law.
