Making appropriations for the Departments of Commerce and Justice, Science, and Related Agencies for the fiscal year ending September 30, 2020, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- ${\it 2\ tives\ of\ the\ United\ States\ of\ America\ in\ Congress\ assembled},$

1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Commerce, Justice,
- 3 Science, Agriculture, Rural Development, Food and Drug
- 4 Administration, Interior, Environment, Military Construc-
- 5 tion, Veterans Affairs, Transportation, and Housing and
- 6 Urban Development Appropriations Act, 2020".

7 DIVISION A—COMMERCE, JUSTICE,

8 SCIENCE, AND RELATED AGENCIES

9 **APPROPRIATIONS ACT, 2020**

- The following sums are appropriated, out of any
- 11 money in the Treasury not otherwise appropriated, for the
- 12 fiscal year ending September 30, 2020, and for other pur-
- 13 poses, namely:
- 14 TITLE I
- 15 DEPARTMENT OF COMMERCE
- 16 International Trade Administration
- 17 OPERATIONS AND ADMINISTRATION
- 18 For necessary expenses for international trade activi-
- 19 ties of the Department of Commerce provided for by law,
- 20 to carry out activities associated with facilitating, attract-
- 21 ing, and retaining business investment in the United
- 22 States, and for engaging in trade promotional activities
- 23 abroad, including expenses of grants and cooperative
- 24 agreements for the purpose of promoting exports of
- 25 United States firms, without regard to sections 3702 and
- 26 3703 of title 44, United States Code; full medical coverage

- 1 for dependent members of immediate families of employees 2 stationed overseas and employees temporarily posted over-
- 3 seas; travel and transportation of employees of the Inter-
- 4 national Trade Administration between two points abroad,
- 5 without regard to section 40118 of title 49, United States
- 6 Code; employment of citizens of the United States and
- 7 aliens by contract for services; rental of space abroad for
- 8 periods not exceeding 10 years, and expenses of alteration,
- 9 repair, or improvement; purchase or construction of tem-
- 10 porary demountable exhibition structures for use abroad;
- 11 payment of tort claims, in the manner authorized in the
- 12 first paragraph of section 2672 of title 28, United States
- 13 Code, when such claims arise in foreign countries; not to
- 14 exceed \$294,300 for official representation expenses
- 15 abroad; purchase of passenger motor vehicles for official
- 16 use abroad, not to exceed \$45,000 per vehicle; obtaining
- 17 insurance on official motor vehicles; and rental of tie lines,
- 18 \$530,000,000 (reduced by \$2,000,000) (increased by
- 19 \$2,000,000) (increased by \$2,000,000) (reduced by
- 20 \$3,000,000) (increased by \$3,000,000), to remain avail-
- 21 able until September 30, 2021, of which \$11,000,000 is
- 22 to be derived from fees to be retained and used by the
- 23 International Trade Administration, notwithstanding sec-
- 24 tion 3302 of title 31, United States Code: Provided, That,
- 25 of amounts provided under this heading, not less than

- 1 \$16,400,000 shall be for China antidumping and counter-
- 2 vailing duty enforcement and compliance activities: Pro-
- 3 vided further, That the provisions of the first sentence of
- 4 section 105(f) and all of section 108(c) of the Mutual Edu-
- 5 cational and Cultural Exchange Act of 1961 (22 U.S.C.
- 6 2455(f) and 2458(c)) shall apply in carrying out these ac-
- 7 tivities; and that for the purpose of this Act, contributions
- 8 under the provisions of the Mutual Educational and Cul-
- 9 tural Exchange Act of 1961 shall include payment for as-
- 10 sessments for services provided as part of these activities.

- For necessary expenses for export administration and
- 14 national security activities of the Department of Com-
- 15 merce, including costs associated with the performance of
- 16 export administration field activities both domestically and
- 17 abroad; full medical coverage for dependent members of
- 18 immediate families of employees stationed overseas; em-
- 19 ployment of citizens of the United States and aliens by
- 20 contract for services abroad; payment of tort claims, in
- 21 the manner authorized in the first paragraph of section
- 22 2672 of title 28, United States Code, when such claims
- 23 arise in foreign countries; not to exceed \$13,500 for offi-
- 24 cial representation expenses abroad; awards of compensa-
- 25 tion to informers under the Export Control Reform Act

- 1 of 2018 (subtitle B of title XVII of the John S. McCain
- 2 National Defense Authorization Act for Fiscal Year 2019;
- 3 Public Law 115–232; 132 Stat. 2208; 50 U.S.C. 4801 et
- 4 seq.), and as authorized by section 1(b) of the Act of June
- 5 15, 1917 (40 Stat. 223; 22 U.S.C. 401(b)); and purchase
- 6 of passenger motor vehicles for official use and motor vehi-
- 7 cles for law enforcement use with special requirement vehi-
- 8 cles eligible for purchase without regard to any price limi-
- 9 tation otherwise established by law, \$127,652,000 (in-
- 10 creased by \$1,000,000) (reduced by \$1,000,000), to re-
- 11 main available until expended: *Provided*, That the provi-
- 12 sions of the first sentence of section 105(f) and all of sec-
- 13 tion 108(c) of the Mutual Educational and Cultural Ex-
- 14 change Act of 1961 (22 U.S.C. 2455(f) and 2458(c)) shall
- 15 apply in carrying out these activities: Provided further,
- 16 That payments and contributions collected and accepted
- 17 for materials or services provided as part of such activities
- 18 may be retained for use in covering the cost of such activi-
- 19 ties, and for providing information to the public with re-
- 20 spect to the export administration and national security
- 21 activities of the Department of Commerce and other ex-
- 22 port control programs of the United States and other gov-
- 23 ernments.

3	For grants for economic development assistance as
4	provided by the Public Works and Economic Development

8	3722 and 3723), \$498,350,000, to remain available until
9	expended, of which \$30,000,000 shall be for grants under

12	For necessary expenses for collecting, compiling, ana
13	lyzing, preparing, and publishing statistics, provided for
14	by law, \$275,000,000: Provided, That, from amounts pro
15	vided herein, funds may be used for promotion, outreach
16	and marketing activities.
17	PERIODIC CENSUSES AND PROGRAMS
18	(INCLUDING TRANSFER OF FUNDS)
19	For necessary expenses for collecting, compiling, ana
20	lyzing, preparing, and publishing statistics for periodic
21	censuses and programs provided for by law, \$675,000,000
22	to remain available until September 30, 2022: Provided
23	That, from amounts provided herein, funds may be used
24	for promotion, outreach, and marketing activities: Pro-
25	vided further, That within the amounts appropriated

- 1 \$3,556,000 shall be transferred to the "Office of Inspector
- 2 General" account for activities associated with carrying
- 3 out investigations and audits related to the Bureau of the
- 4 Census.
- 5 In addition to the amounts provided under this head-
- 6 ing for the 2020 Census, \$7,500,000,000, to remain avail-
- 7 able until September 30, 2022, is new budget authority
- 8 for the 2020 Census as specified for the purposes of sec-

- 14 SALARIES AND EXPENSES
- For necessary expenses, as provided for by law, of
- 16 the National Telecommunications and Information Ad-
- 17 ministration (NTIA), \$42,411,000 (increased by
- 18 \$1,000,000) (reduced by \$1,000,000), to remain available
- 19 until September 30, 2021: Provided, That, notwith-
- 20 standing 31 U.S.C. 1535(d), the Secretary of Commerce
- 21 shall charge Federal agencies for costs incurred in spec-
- 22 trum management, analysis, operations, and related serv-
- 23 ices, and such fees shall be retained and used as offsetting
- 24 collections for costs of such spectrum services, to remain
- 25 available until expended: Provided further, That the Sec-

- 1 retary of Commerce is authorized to retain and use as off-
- 2 setting collections all funds transferred, or previously
- 3 transferred, from other Government agencies for all costs
- 4 incurred in telecommunications research, engineering, and

- 12 For the administration of prior-year grants, recov-
- 13 eries and unobligated balances of funds previously appro-
- 14 priated are available for the administration of all open
- 15 grants until their expiration.
- 16 United States Patent and Trademark Office
- 17 SALARIES AND EXPENSES
- 18 (INCLUDING TRANSFERS OF FUNDS)
- 19 For necessary expenses of the United States Patent
- 20 and Trademark Office (USPTO) provided for by law, in-
- 21 cluding defense of suits instituted against the Under Sec-
- 22 retary of Commerce for Intellectual Property and Director
- 23 of the USPTO, \$3,450,681,000, to remain available until
- 24 expended: *Provided*, That the sum herein appropriated
- 25 from the general fund shall be reduced as offsetting collec-

- 1 tions of fees and surcharges assessed and collected by the
- 2 USPTO under any law are received during fiscal year
- 3 2020, so as to result in a fiscal year 2020 appropriation
- 4 from the general fund estimated at \$0: Provided further,
- 5 That during fiscal year 2020, should the total amount of
- 6 such offsetting collections be less than \$3,450,681,000
- 7 this amount shall be reduced accordingly: Provided fur-
- 8 ther, That any amount received in excess of
- 9 \$3,450,681,000 in fiscal year 2020 and deposited in the
- 10 Patent and Trademark Fee Reserve Fund shall remain
- 11 available until expended: Provided further, That the Direc-
- 12 tor of USPTO shall submit a spending plan to the Com-
- 13 mittees on Appropriations of the House of Representatives
- 14 and the Senate for any amounts made available by the
- 15 preceding proviso and such spending plan shall be treated
- 16 as a reprogramming under section 505 of this Act and
- 17 shall not be available for obligation or expenditure except
- 18 in compliance with the procedures set forth in that section:
- 19 Provided further, That any amounts reprogrammed in ac-
- 20 cordance with the preceding proviso shall be transferred
- 21 to the United States Patent and Trademark Office "Sala-
- 22 ries and Expenses" account: Provided further, That from
- 23 amounts provided herein, not to exceed \$900 shall be
- 24 made available in fiscal year 2020 for official reception
- 25 and representation expenses: Provided further, That in fis-

- 1 cal year 2020 from the amounts made available for "Sala-
- 2 ries and Expenses" for the USPTO, the amounts nec-
- 3 essary to pay (1) the difference between the percentage
- 4 of basic pay contributed by the USPTO and employees
- 5 under section 8334(a) of title 5, United States Code, and
- 6 the normal cost percentage (as defined by section
- 7 8331(17) of that title) as provided by the Office of Per-
- 8 sonnel Management (OPM) for USPTO's specific use, of
- 9 basic pay, of employees subject to subchapter III of chap-
- 10 ter 83 of that title, and (2) the present value of the other-
- 11 wise unfunded accruing costs, as determined by OPM for
- 12 USPTO's specific use of post-retirement life insurance
- 13 and post-retirement health benefits coverage for all
- 14 USPTO employees who are enrolled in Federal Employees

- 4 ed by section 22 of the Leahy-Smith America Invents Act
- 5 (Public Law 112–29): Provided further, That within the
- 6 amounts appropriated, \$1,500,000 shall be transferred to
- 7 the "Office of Inspector General" account for activities as-
- 8 sociated with carrying out investigations and audits re-
- 9 lated to the USPTO.
- 10 National Institute of Standards and Technology
- 11 SCIENTIFIC AND TECHNICAL RESEARCH AND SERVICES
- 12 (INCLUDING TRANSFER OF FUNDS)
- For necessary expenses of the National Institute of
- 14 Standards and Technology (NIST), \$751,000,000 (re-
- 15 duced by \$4,000,000) (increased by \$4,000,000), to re-
- 16 main available until expended, of which not to exceed
- 17 \$9,000,000 may be transferred to the "Working Capital
- 18 Fund": Provided, That not to exceed \$5,000 shall be for
- 19 official reception and representation expenses: Provided
- 20 further, That NIST may provide local transportation for
- 21 summer undergraduate research fellowship program par-
- 22 ticipants.
- 23 INDUSTRIAL TECHNOLOGY SERVICES
- 24 For necessary expenses for industrial technology
- 25 services, \$169,172,000, to remain available until ex-

- 1 pended, of which \$154,000,000 shall be for the Hollings
- 2 Manufacturing Extension Partnership, and of which
- 3 \$15,172,000 shall be for the National Network for Manu-
- 4 facturing Innovation (also known as "Manufacturing
- 5 USA'').
- 6 CONSTRUCTION OF RESEARCH FACILITIES
- 7 For construction of new research facilities, including
- 8 architectural and engineering design, and for renovation
- 9 and maintenance of existing facilities, not otherwise pro-
- 10 vided for the National Institute of Standards and Tech-
- 11 nology, as authorized by sections 13 through 15 of the
- 12 National Institute of Standards and Technology Act (15
- 13 U.S.C. 278c–278e), \$120,000,000 (increased by
- 14 \$120,000,000) (reduced by \$120,000,000), to remain
- 15 available until expended: *Provided*, That the Secretary of
- 16 Commerce shall include in the budget justification mate-
- 17 rials that the Secretary submits to Congress in support
- 18 of the Department of Commerce budget (as submitted
- 19 with the budget of the President under section 1105(a)
- 20 of title 31, United States Code) an estimate for each Na-
- 21 tional Institute of Standards and Technology construction

5	OPERATIONS, RESEARCH, AND FACILITIES
6	(INCLUDING TRANSFER OF FUNDS)
7	For necessary expenses of activities authorized by law
8	for the National Oceanic and Atmospheric Administration,
9	including maintenance, operation, and hire of aircraft and
10	vessels; pilot programs for state-led fisheries management,
11	notwithstanding any other provision of law; grants, con-
12	tracts, or other payments to nonprofit organizations for
13	the purposes of conducting activities pursuant to coopera-
14	tive agreements; and relocation of facilities,
15	\$3,920,625,000 (reduced by \$3,600,000) (increased by
16	\$2,000,000) (reduced by \$1,500,000) (increased by
17	\$1,500,000) (increased by \$1,500,000), to remain avail-
18	able until September 30, 2021: Provided, That fees and
19	donations received by the National Ocean Service for the
20	management of national marine sanctuaries may be re-
21	tained and used for the salaries and expenses associated
22	with those activities, notwithstanding section 3302 of title
23	31, United States Code: Provided further, That in addi-
24	tion, \$177,782,000 shall be derived by transfer from the
25	fund entitled "Promote and Develop Fishery Products and

- 1 Research Pertaining to American Fisheries", which shall
- 2 only be used for the Fisheries Science and Management
- 3 program activities: Provided further, That of the
- 4 \$4,115,907,000 (increased by \$2,000,000) (increased by
- 5 \$1,500,000) provided for in direct obligations under this
- 6 heading, \$3,920,625,000 (increased by \$2,000,000) (in-
- 7 creased by \$1,500,000) is appropriated from the general
- 8 fund, \$177,782,000 is provided by transfer, and
- 9 \$17,500,000 is derived from recoveries of prior year obli-
- 10 gations: Provided further, That any deviation from the
- 11 amounts designated for specific activities in the report ac-
- 12 companying this Act, or any use of deobligated balances
- 13 of funds provided under this heading in previous years,
- 14 shall be subject to the procedures set forth in section 505
- 15 of this Act: Provided further, That in addition, for nec-
- 16 essary retired pay expenses under the Retired Service-
- 17 man's Family Protection and Survivor Benefits Plan, and
- 18 for payments for the medical care of retired personnel and
- 19 their dependents under the Dependents' Medical Care Act
- 20 (10 U.S.C. ch. 55), such sums as may be necessary.
- 21 PROCUREMENT, ACQUISITION, AND CONSTRUCTION
- 22 (INCLUDING TRANSFER OF FUNDS)
- For procurement, acquisition, and construction of
- 24 capital assets, including alteration and modification costs,
- 25 of the National Oceanic and Atmospheric Administration,

- 1 \$1,496,000,000 (reduced by \$9,000,000) (increased by
- 2 \$9,000,000), to remain available until September 30,
- 3 2022, except that funds provided for acquisition and con-
- 4 struction of vessels and construction of facilities shall re-
- 5 main available until expended: *Provided*, That of the
- 6 \$1,509,000,000 provided for in direct obligations under
- 7 this heading, \$1,496,000,000 is appropriated from the
- 8 general fund and \$13,000,000 is provided from recoveries
- 9 of prior year obligations: Provided further, That any devi-
- 10 ation from the amounts designated for specific activities
- 11 in the report accompanying this Act, or any use of
- 12 deobligated balances of funds provided under this heading
- 13 in previous years, shall be subject to the procedures set
- 14 forth in section 505 of this Act: Provided further, That
- 15 the Secretary of Commerce shall include in budget jus-
- 16 tification materials that the Secretary submits to Congress
- 17 in support of the Department of Commerce budget (as
- 18 submitted with the budget of the President under section
- 19 1105(a) of title 31, United States Code) an estimate for
- 20 each National Oceanic and Atmospheric Administration
- 21 procurement, acquisition, or construction project having a
- 22 total of more than \$5,000,000 and simultaneously the
- 23 budget justification shall include an estimate of the budg-
- 24 etary requirements for each such project for each of the
- 25 5 subsequent fiscal years: Provided further, That, within

- 1 the amounts appropriated, \$1,302,000 shall be transferred
- 2 to the "Office of Inspector General" account for activities
- 3 associated with carrying out investigations and audits re-
- 4 lated to satellite procurement, acquisition, and construc-
- 5 tion.
- 6 PACIFIC COASTAL SALMON RECOVERY
- 7 For necessary expenses associated with the restora-
- 8 tion of Pacific salmon populations, \$65,000,000, to re-
- 9 main available until September 30, 2021: Provided, That,
- 10 of the funds provided herein, the Secretary of Commerce
- 11 may issue grants to the States of Washington, Oregon,
- 12 Idaho, Nevada, California, and Alaska, and to the Feder-
- 13 ally recognized tribes of the Columbia River and Pacific
- 14 Coast (including Alaska), for projects necessary for con-
- 15 servation of salmon and steelhead populations that are
- 16 listed as threatened or endangered, or that are identified
- 17 by a State as at-risk to be so listed, for maintaining popu-
- 18 lations necessary for exercise of tribal treaty fishing rights
- 19 or native subsistence fishing, or for conservation of Pacific
- 20 coastal salmon and steelhead habitat, based on guidelines
- 21 to be developed by the Secretary of Commerce: Provided
- 22 further, That all funds shall be allocated based on sci-
- 23 entific and other merit principles and shall not be available
- 24 for marketing activities: Provided further, That funds dis-
- 25 bursed to States shall be subject to a matching require-

1	ment of funds or documented in-kind contributions of at
2	least 33 percent of the Federal funds.
3	FISHERMEN'S CONTINGENCY FUND
4	For carrying out the provisions of title IV of Public
5	Law 95–372, not to exceed \$349,000, to be derived from
6	receipts collected pursuant to that Act, to remain available
7	until expended.
8	FISHERY DISASTER ASSISTANCE
9	For the necessary expenses associated with the miti-
10	gation of fishery disasters, \$15,000,000, to remain avail-
11	able until expended: Provided, That funds shall be used
12	for mitigating the effects of commercial fishery failures
13	and fishery resource disasters as declared by the Secretary
14	of Commerce.
15	FISHERIES FINANCE PROGRAM ACCOUNT
16	Subject to section 502 of the Congressional Budget
17	Act of 1974, during fiscal year 2020, obligations of direct
18	loans may not exceed \$24,000,000 for Individual Fishing
19	Quota loans and not to exceed \$100,000,000 for tradi-
20	tional direct loans as authorized by the Merchant Marine
21	Act of 1936.
22	DEPARTMENTAL MANAGEMENT
23	SALARIES AND EXPENSES
24	For necessary expenses for the management of the
25	Department of Commerce provided for by law, including

- 1 not to exceed \$4,500 for official reception and representa-
- 2 tion, \$40,000,000 (reduced by \$2,500,000) (increased by \$2,500,000)
- 3 \$3,600,000) (reduced by \$2,000,000) (reduced by
- 4 \$2,000,000) (reduced by \$914,000): *Provided*, That of the
- 5 funds provided under this heading, \$15,000,000 shall be
- 6 withheld from obligation until the Secretary updates and
- 7 resubmits to the Committees on Appropriations of the
- 8 House of Representatives and the Senate the plan for ex-
- 9 penditure described in the third proviso under the heading
- 10 "Bureau of the Census—Periodic Census and Programs"
- 11 in division C of Public Law 116–6.
- 12 RENOVATION AND MODERNIZATION
- For necessary expenses for the renovation and mod-
- 14 ernization of Department of Commerce facilities,
- 15 \$1,100,000, to remain available until expended.
- 16 OFFICE OF INSPECTOR GENERAL
- For necessary expenses of the Office of Inspector
- 18 General in carrying out the provisions of the Inspector
- 19 General Act of 1978 (5 U.S.C. App.), \$35,043,000 (in-
- 20 creased by \$914,000): Provided, That notwithstanding
- 21 section 6413(b) of the Middle Class Tax Relief and Job
- 22 Creation Act of 2012 (Public Law 112–96), \$2,000,000,
- 23 to remain available until expended, from the amounts pro-
- 24 vided under this heading, shall be derived from the Public
- 25 Safety Trust Fund for activities associated with carrying

- 1 out investigations and audits related to the First Re-
- 2 sponder Network Authority (FirstNet).
- 3 General Provisions—Department of Commerce

- (2) Any project or activity, which may be deferred through reprogramming, shall not later be accomplished by means of further reprogramming, but instead, funds should again be sought for the deferred project or activity through the regular appropriations process.
- (3) Except under the most urgent situations, reprogramming should not be employed to initiate new programs or increase allocations specifically denied or limited by the Congress, or to decrease allocations specifically increased by the Congress.

(4) New programs requested in the budget should not be initiated before enactment of the bill without notification to, and the approval of, the Committees on Appropriations of the House of Rep-resentatives and the Senate (hereinafter "the Com-mittees"). This restriction applies to all such actions regardless of whether a formal reprogramming of funds is required to begin the program.

(c) Criteria.—

- (1) A reprogramming shall be submitted to the Committees in writing 30 days prior to implementation if—
 - (A) it exceeds \$1,000,000 individually or cumulatively or results in a cumulative increase or decrease of more than 10 percent of funds annually in any affected program, project, or activity;
 - (B) it is a reorganization; or
 - (C) it is an operating plan or any later modification thereof as submitted under subsection (i) of this section: *Provided*, That such plan or modification thereof also meets any of the other criteria under subsection (c)(1) of this section.

- (2) No funds shall be available for obligation or expenditure through a reprogramming until 30 days after the receipt by the Committees of a notice of proposed reprogramming.
 - (3) A reprogramming shall be considered approved 30 days after receipt if the Committees have posed no objection. However, agencies shall not implement the reprogramming and shall extend the notification period if specifically requested by either Committee.

(d) Exceptions.—

- (1) With regard to the tribal priority allocations of the Bureau of Indian Affairs, there is no restriction on reprogrammings among these programs. However, the Bureau shall report on all reprogrammings made during a given fiscal year no later than 60 days after the end of the fiscal year.
- (2) With regard to the Environmental Protection Agency, State and Tribal Assistance Grants account, the Committees do not require reprogramming requests associated with States and Tribal Partnership Grants.
- (3) With regard to funding for Park Management subactivities within the National Park Service Operations of the National Park System account, re-

programming guidelines apply at the activity level, not the more detailed level as shown in the Committee report. The National Park Service shall report on actual spending at the more detailed level no later than 60 days after the end of the fiscal year and show its impact on the succeeding year budget at the more detailed level in the budget justification submitted to the Congress in the subsequent fiscal year for the purpose of updating the Committee support table.
