A BILL

To provide for the rescission of certain waivers and licenses relating to Iran, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. RESCISSION OF CERTAIN WAIVERS AND LI-**
4 **CENSES.**

5 (a) IN GENERAL.—On the date of enactment of this
6 Act, the following measures shall be terminated:

7 (1) The waiver exercised on the pursuant to
8 section 1245(d)(5) of the National Defense Author-
9 ization Act for Fiscal Year 2012 and sections
10 1244(i) and 1247(f) of the Iran Freedom and
11 Counter-Proliferation Act of 2012 and transmitted
12 to Congress on September 11, 2023, for the transfer
13 of certain funds from the Republic of Korea to
14 Qatar.

15 (2) Any general or specific license issued by the
16 Office of Foreign Assets Control at the Department
17 of the Treasury directly or indirectly related to the
18 funds cited in paragraph (1).

1 (b) LIMITATION.—The President may not reissue any
2 new waiver or license described in paragraph (1) or (2)
3 of subsection (a) for the same or similar purposes.

4 **SEC. 2. LIMITATION OF APPLICABILITY OF CERTAIN LI-**
5 **CENSES.**

6 Notwithstanding any other provision of law, on and
7 after the date of the enactment of this Act, the President
8 may not—

9 (1) exercise the waiver authority described in
10 section 1245(d)(5) of the National Defense Author-
11 ization Act for Fiscal Year 2012 and sections
12 1244(i) and 1247(f) of the Iran Freedom and
13 Counter-Proliferation Act of 2012 permitting the
14 Government of Iran or any Iranian person access to
15 any account established or maintained pursuant to
16 or in accordance with section 1245(d)(4)(D)(ii)(II)
17 of the National Defense Authorization Act for Fiscal
18 Year 2012; or

19 (2) issue a general or specific license, frequently
20 asked question, or any other licensing action or
21 guidance permitting the Government of Iran or any
22 Iranian person access to or to benefit directly or in-
23 directly from any account established pursuant to or
24 in accordance with any account described in

1 1245(d)(4)(D)(ii)(II) of the National Defense Au-
2 thorization Act for Fiscal Year 2012.
