## A BILL

To provide that the Executive order entitled “Promoting Energy Independence and Economic Growth” (March 28, 2017), shall have no force or effect, to prohibit the use of Federal funds to enforce the Executive order, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        This Act may be cited as the “Congressional Leader-  
5 ship In Mitigating Administration Threats to the Earth  
6 Act” or the “CLIMATE Act”.

7 **SEC. 2. EXECUTIVE ORDER TO HAVE NO FORCE OR EFFECT.**

8        Beginning on March 28, 2017, the Executive order  
9 entitled “Promoting Energy Independence and Economic  
10 Growth” (March 28, 2017), is null and void, shall have  
11 no force or effect, and may not be implemented, adminis-  
12 tered, or enforced.

13 **SEC. 3. NO FUNDS AVAILABLE.**

14        No Federal funds may be used to implement, admin-  
15 ister, or enforce (including through the issuance of any  
16 regulations) the Executive order entitled “Promoting En-  
17 ergy Independence and Economic Growth” (March 28,  
18 2017).

19 **SEC. 4. EFFECTIVE DATE.**

20        This Act shall take effect on March 28, 2017.
