## **AN ACT**

To require a review of Department of Homeland Security  
trusted traveler programs, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Trusted Traveler Re-  
5       consideration and Restoration Act of 2019”.

6       **SEC. 2. COMPTROLLER GENERAL REVIEW.**

7       Not later than 1 year after the date of the enactment  
8       of this Act, the Comptroller General of the United States

1 shall conduct a review of Department of Homeland Secu-  
2 rity trusted traveler programs. Such review shall examine  
3 the following:

4           (1) The extent to which the Department of  
5 Homeland Security tracks data and monitors trends  
6 related to trusted traveler programs, including root  
7 causes for identity-matching errors resulting in an  
8 individual's enrollment in a trusted traveler program  
9 being reinstated.

10           (2) Whether the Department coordinates with  
11 the heads of other relevant Federal, State, local,  
12 Tribal, or territorial entities regarding redress proce-  
13 dures for disqualifying offenses not covered by the  
14 Department's own redress processes but which of-  
15 fenses impact an individual's enrollment in a trusted  
16 traveler program.

17           (3) How the Department may improve individ-  
18 uals' access to reconsideration procedures regarding  
19 a disqualifying offense for enrollment in a trusted  
20 traveler program that requires the involvement of  
21 any other Federal, State, local, Tribal, or territorial  
22 entity.

23           (4) The extent to which travelers are informed  
24 about reconsideration procedures regarding enroll-  
25 ment in a trusted traveler program.

1 **SEC. 3. ENROLLMENT REDRESS.**

2       Notwithstanding any other provision of law, the Sec-  
3 retary of Homeland Security shall, with respect to an indi-  
4 vidual whose enrollment in a trusted traveler program was  
5 revoked in error extend by an amount of time equal to  
6 the period of revocation the period of active enrollment  
7 in such a program upon re-enrollment in such a program  
8 by such an individual.
