## A BILL ENTITLED

1 AN ACT concerning

2 **Estates and Trusts – Closed Estates – Subsequent Discovery of Check**

3 FOR the purpose of authorizing a court, following the discovery of a check to a decedent or  
4 the estate of a decedent payable for a sum not exceeding a certain amount after the  
5 estate is closed and the appointment of the personal representative is terminated, to  
6 enter an order authorizing a certain interested person to indorse and deposit the  
7 check into the interested person's bank account for a certain purpose under certain  
8 circumstances; making stylistic changes; and generally relating to the  
9 administration of decedents' estates.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
16 That the Laws of Maryland read as follows:

17 **Article – Estates and Trusts**

18 10–104.

19 (a) **[If] EXCEPT AS PROVIDED IN SUBSECTION (C) OF THIS SECTION, IF**  
20 property is discovered after an estate has been closed and the appointment of the personal  
21 representative has been terminated **[pursuant to] UNDER § 10–101** of this subtitle, the  
22 court, on petition of an interested person and on **[such] ANY** notice as **[it] THE COURT** may  
23 direct, may appoint the same or a successor personal representative and make other  
24 appropriate orders.

1           (b) Further proceedings shall be conducted [pursuant to] **IN ACCORDANCE WITH**  
2 the provisions of the estates of decedents law as may be applicable, but no claim previously  
3 barred may be asserted in the reopened administration.

4           **(C) IF A CHECK PAYABLE TO A DECEDENT OR THE ESTATE OF A DECEDENT**  
5 **FOR A SUM NOT EXCEEDING \$1,000 IS DISCOVERED AFTER AN ESTATE IS CLOSED**  
6 **AND THE APPOINTMENT OF THE PERSONAL REPRESENTATIVE HAS TERMINATED**  
7 **UNDER § 10-101 OF THIS SUBTITLE, ON A VERIFIED REQUEST MADE BY AN**  
8 **INTERESTED PERSON, THE COURT MAY ENTER AN ORDER AUTHORIZING THE**  
9 **INTERESTED PERSON TO INDORSE AND DEPOSIT THE CHECK INTO THE INTERESTED**  
10 **PERSON'S BANK ACCOUNT FOR THE LIMITED PURPOSE OF DISTRIBUTING THE**  
11 **FUNDS IN ACCORDANCE WITH THE WILL OR, IF THE DECEDENT DIED INTESTATE, IN**  
12 **ACCORDANCE WITH TITLE 3, SUBTITLE 1 OF THIS ARTICLE.**

13           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
14 October 1, 2020.
