A BILL

To require the Secretary of State to determine whether the Russian Federation should be designated as a state sponsor of terrorism and whether Russian-sponsored armed entities in Ukraine should be designated as foreign terrorist organizations, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Stopping Malign Ac-
- 5 tivities from Russian Terrorism Act".

1	SEC. 2. DEFINITIONS.
2	In this Act:
3	(1) Appropriate congressional commit-
4	TEES.—The term "appropriate congressional com-
5	mittees" means—
6	(A) the Committee on Foreign Relations of
7	the Senate; and
8	(B) the Committee on Foreign Affairs of
9	the House of Representatives.
10	(2) State sponsor of terrorism.—The term
11	"state sponsor of terrorism" means a country the
12	government of which the Secretary of State has de-
13	termined, for purposes of section 1754(c)(1)(A)(i) of
14	the Export Control Reform Act of 2018 (50 U.S.C.
15	4813(c)(1)(A)(i)), section $620A$ of the Foreign As-
16	sistance Act of 1961 (22 U.S.C. 2371), section 40
17	of the Arms Export Control Act (22 U.S.C. 2780),
18	or any other provision of law, is a government that
19	has repeatedly provided support for acts of inter-
20	national terrorism.
21	SEC. 3. DETERMINATION ON THE DESIGNATION OF THE
22	RUSSIAN FEDERATION AS A STATE SPONSOR
23	OF TERRORISM.
24	(a) In General.—Not later than 90 days after the
25	date of the enactment of this Act, the Secretary of State
26	shall submit a determination to the appropriate congres-

- 3 sor of terrorism.
- 4 (b) FORM.—The determination required under sub-
- 5 section (a) shall be submitted in unclassified form, but
- 6 may include a classified annex, if appropriate.
- 7 SEC. 4. DETERMINATION ON THE DESIGNATION OF THE
- 8 RUSSIAN-SUPPORTED ARMED FORCES IN THE
- 9 DONBAS REGION OF UKRAINE AS FOREIGN
- 10 TERRORIST ORGANIZATIONS.
- 11 (a) IN GENERAL.—Not later than 90 days after the
- 12 date of the enactment of this Act, the Secretary of State
- 13 shall submit a determination to the appropriate congres-
- 14 sional committees that indicates whether armed entities
- 15 that are physically present in the Donbas region of
- 16 Ukraine and are controlled or aided by the Russian Fed-
- 17 eration, or armed entities that are associated or controlled
- 18 by the "Donetsk People's Republic" or the "Lugansk Peo-
- 19 ple's Republic", meet the criteria to be designated as for-
- 20 eign terrorist organizations under section 219 of the Im-
- 21 migration and Nationality Act (8 U.S.C. 1189).
- 22 (b) FORM.—The determination required under sub-
- 23 section (a) shall be submitted in unclassified form, but
- 24 may include a classified annex, if appropriate.

1 SEC. 5. RULES OF CONSTRUCTION.

2	Nothing in this Act may be construed—
3	(1) to authorize the use of military force; or
4	(2) to limit bilateral military-to-military dia-
5	logue between the United States and the Russian
6	Federation for the purpose of reducing the risk of
7	conflict.
