1 AN ACT concerning

Workgroup to Study Basic Economic Security

- 3 FOR the purpose of establishing the Workgroup to Study Basic Economic Security; 4 providing for the composition, cochairs, and staffing of the Workgroup; establishing 5 the duties of the Workgroup; prohibiting a member of the Workgroup from receiving 6 certain compensation, but authorizing the reimbursement of certain expenses; 7 requiring the Workgroup to report its findings and recommendations to the Governor 8 and the General Assembly on or before a certain date; providing for the termination 9 of this Act; and generally relating to the Workgroup to Study Basic Economic 10 Security.
- 11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 12 That:
- 13 (a) There is a Workgroup to Study Basic Economic Security.
- 14 (b) The Workgroup consists of the following members:
- 15 (1) the Chair of the Senate Finance Committee;
- 16 (2) the Chair of the House Economic Matters Committee;
- 17 (3) two members of the House of Delegates with an interest in basic 18 economic security, appointed by the Speaker of the House;
- 19 (4) the Secretary of Commerce, or the Secretary's designee;
- 20 (5) the Secretary of Labor, or the Secretary's designee;

7 8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2020. It shall remain effective for a period of 1 year and, at the end of June 30, 2021, this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect.
