A party who considers that a matter of which an admission has been requested presents a genuine issue for trial may not, on that ground alone, object to the request; he <u>or she</u> may, subject to the provisions of subsection D of Section 3237 of this title, deny the matter or set forth reasons why he <u>or she</u> cannot admit or deny it.

The party who has requested the admission may move to determine the sufficiency of the answers or objections. Unless the court determines that an objection is justified, it shall order that an answer be served. If the court determines that an answer does not comply with the requirements of this section, it may order either that the matter is admitted or that an amended answer be served.

The court may, in lieu of these orders, determine that final disposition of the request be made at a pretrial conference or at a designated time prior to trial. The provisions of paragraph 4 of subsection A of Section 3237 of this title apply to the award of expenses incurred in relation to the motion.

B. EFFECT OF ADMISSION. Any matter admitted under this section is conclusively established unless the court on motion permits

1	withdrawal or amendment of the admission. The court may permit
2	withdrawal or amendment of an admission when the presentation of the
3	merits of the action will be subserved thereby and the party who
4	obtained the admission fails to satisfy the court that withdrawal or
5	amendment will prejudice him or her in maintaining his or her action
6	or defense on the merits.
7	C. SCOPE OF ADMISSIONS. Any admission made by a party under
8	this section is for the purpose of the pending action only and is
9	not an admission by him for any other purpose nor may it be used
10	against him or her in any other proceeding.
