 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Trade Assistance for

5 Farmers Act of 2019".

- 6 SEC. 2. FINDINGS.
- 7 Congress finds the following:

1	(1) In recognition that trade policy can result
2	in disparate and disruptive changes to the economy,
3	the Trade Adjustment Assistance program was en-
4	acted to help workers adversely impacted by the
5	trade policy decisions of the Federal Government.
6	(2) The Trump Administration has made clear
7	that it intends to aggressively use Federal trade
8	statutes, including section 232 of the Trade Expan-
9	sion Act of 1962 (19 U.S.C. 1862), section 301 of
10	the Trade Act of 1974 (19 U.S.C. 2411), and poten-
11	tially the International Emergency Economic Powers
12	Act (Public Law 95–223), to increase tariffs on se-
13	lected imports.
14	(3) Foreign countries affected by such tariff in-
15	creases have, as of the date of the enactment of this
16	Act, already raised tariffs on United States agricul-
17	tural exports or have indicated that they intend to
18	respond by raising tariffs on such agricultural ex-
19	ports.
20	(4) Increased tariffs on such agricultural ex-
21	ports threaten to cost United States agricultural
22	producers global market share and reduce the in-
23	come of producers of affected commodities.
24	(5) Farmers adversely impacted by these effects
25	deserve adjustment assistance.

1	SEC. 3. ADJUSTMENT ASSISTANCE FOR RETALIATORY TAR-
2	IFF INCREASES.
3	Section 292(c) of the Trade Act of 1974 (19 U.S.C.
4	2401a(c)) is amended—
5	(1) by striking paragraphs (2) and (3) ; and
6	(2) by inserting after paragraph (1) the fol-
7	lowing:
8	"(2) either—
9	"(A) the volume of imports of articles like,
10	or directly competitive with, the agricultural
11	commodity produced by the group in the mar-
12	keting year with respect to which the group
13	files the petition increased compared to the av-
14	erage volume of such imports during the 3 mar-
15	keting years preceding such marketing year; or
16	"(B)(i) the volume of exports of the agri-
17	cultural commodity produced by the group in
18	the marketing year with respect to which the
19	group files the petition decreased compared to
20	the average volume of such exports during the
21	3 marketing years preceding such marketing
22	year; and
23	"(ii) the decrease in exports described in
24	clause (i) resulted in whole or in part from tar-
25	iffs imposed on such exports by a foreign coun-
26	try in response to United States tariffs imposed

1	on imports from such country pursuant to ac-
2	tion taken under the authority of—
3	"(I) section 232 of the Trade Expan-
4	sion Act of 1962 (19 U.S.C. 1862);
5	"(II) section 301 of the Trade Act of
6	1974 (19 U.S.C. 2411); or
7	"(III) the International Emergency
8	Economic Powers Act (Public Law 95–
9	223); and
10	"(3) the increase in imports under subpara-
11	graph (B)(i) or the decrease in exports under sub-
12	paragraph (B)(ii) contributed importantly to the de-
13	crease in the national average price, quantity of pro-
14	duction, or value of production of, or cash receipts
15	for, the agricultural commodity, as described in
16	paragraph (1).".
