A BILL

To extend the Secure Rural Schools and Community Self-
Determination Act of 2000.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. EXTENSION OF SECURE RURAL SCHOOLS AND**
4 **COMMUNITY SELF-DETERMINATION ACT OF**
5 **2000.**

6 (a) SECURE PAYMENTS FOR STATES AND COUNTIES
7 CONTAINING FEDERAL LAND.—

8 (1) SECURE PAYMENTS.—Section 101 of the
9 Secure Rural Schools and Community Self-Deter-
10 mination Act of 2000 (16 U.S.C. 7111) is amended,

1 in subsections (a) and (b), by striking “and 2018”
2 each place it appears and inserting “2018, and
3 2019”.

4 (2) PAYMENTS TO STATES AND COUNTIES.—

5 (A) ELECTION TO RECEIVE PAYMENT
6 AMOUNT.—Section 102(b) of the Secure Rural
7 Schools and Community Self-Determination Act
8 of 2000 (16 U.S.C. 7112(b)) is amended—

9 (i) in paragraph (1)(D)—

10 (I) in the paragraph heading, by
11 striking “FOR FISCAL YEARS 2017 AND
12 2018” and inserting “FOR EACH OF
13 FISCAL YEARS 2017 THROUGH 2019”;
14 and

15 (II) by striking “for fiscal years
16 2017 or 2018” and inserting “for
17 each of fiscal years 2017 through
18 2019”; and

19 (ii) in paragraph (2), in subpara-
20 graphs (A) and (B), by striking “for fiscal
21 years 2017 and 2018” each place it ap-
22 pears and inserting “for each of fiscal
23 years 2017 through 2019”.

24 (B) EXPENDITURE RULES FOR ELIGIBLE
25 COUNTIES.—Section 102(d) of the Secure Rural

1 Schools and Community Self-Determination Act
2 of 2000 (16 U.S.C. 7112(d)) is amended—

3 (i) in paragraph (1)(F)—

4 (I) in the paragraph heading, by
5 striking “FOR FISCAL YEARS 2017 AND
6 2018” and inserting “FOR EACH OF
7 FISCAL YEARS 2017 THROUGH 2019”;
8 and

9 (II) by striking “for fiscal years
10 2017 and 2018” and inserting “for
11 each of fiscal years 2017 through
12 2019”; and

13 (ii) in paragraph (3)(D)—

14 (I) in the paragraph heading, by
15 striking “FOR FISCAL YEARS 2017 AND
16 2018” and inserting “FOR EACH OF
17 FISCAL YEARS 2017 THROUGH 2019”;
18 and

19 (II) by striking “for fiscal years
20 2017 and 2018” and inserting “for
21 each of fiscal years 2017 through
22 2019”.

23 (C) DISTRIBUTION OF PAYMENTS TO ELI-
24 GIBLE COUNTIES.—Section 103(d)(2) of the Se-
25 cure Rural Schools and Community Self-Deter-

1 mination Act of 2000 (16 U.S.C. 7113(d)(2)) is
2 amended by striking “through and for fiscal
3 years 2017 and 2018” and inserting “through
4 2015 and for each of fiscal years 2017 through
5 2019”.

6 (b) EXTENSION OF AUTHORITY TO CONDUCT SPE-
7 CIAL PROJECTS ON FEDERAL LAND.—Section 208 of the
8 Secure Rural Schools and Community Self-Determination
9 Act of 2000 (16 U.S.C. 7128) is amended—

10 (1) in subsection (a), by striking “2020” and
11 inserting “2021”; and

12 (2) in subsection (b), by striking “2021” and
13 inserting “2022”.

14 (c) EXTENSION OF AUTHORITY TO EXPEND COUNTY
15 FUNDS.—Section 304 of the Secure Rural Schools and
16 Community Self-Determination Act of 2000 (16 U.S.C.
17 7144) is amended—

18 (1) in subsection (a), by striking “2020” and
19 inserting “2021”; and

20 (2) in subsection (b), by striking “2021” and
21 inserting “2022”.
