SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Extension of the Carib-
- 3 bean Basin Economic Recovery Act".
- 4 SEC. 2. EXTENSION OF THE CARIBBEAN BASIN ECONOMIC
- 5 RECOVERY ACT.
- 6 Section 213 of the Caribbean Basin Economic Recov-
- 7 ery Act (19 U.S.C. 2703) is amended as follows:
- 8 (1) Extension for certain knit apparel
- 9 ARTICLES.—In clause (iii) of subsection (b)(2)(A)—
- 10 (A) in subclause (II)(cc), by striking "Sep-
- tember 30, 2020" and inserting "September 30,
- 12 2030"; and
- 13 (B) in subclause (IV)(dd), by striking
- "September 30, 2020" and inserting "Sep-
- 15 tember 30, 2030".
- 16 (2) Extension of Limitation with respect
- 17 TO CERTAIN OTHER APPAREL ARTICLES.—In clause
- 18 (iv)(II) of such subsection, by striking "18" and in-
- 19 serting "28".
- 20 (3) Extension of transition period.—In
- subsection (b)(5)(D)(i), by striking "September 30,
- 22 2020" and inserting "September 30, 2030".
- 23 SEC. 3. CUSTOMS USER FEES.
- 24 (a) IN GENERAL.—Section 13031(j)(3) of the Con-
- 25 solidated Omnibus Budget Reconciliation Act of 1985 (19
- 26 U.S.C. 58c(j)(3)) is amended—

- 1 (1) in subparagraph (A), by striking "Sep-
- tember 30, 2029" and inserting "October 21,
- 3 2029"; and
- 4 (2) in subparagraph (B)(i), by striking "Sep-
- 5 tember 30, 2029" and inserting "October 21,
- 6 2029".
- 7 (b) Rate for Merchandise Processing Fees.—
- 8 Section 503 of the United States–Korea Free Trade
- 9 Agreement Implementation Act (Public Law 112–41; 19
- 10 U.S.C. 3805 note) is amended by striking "September 30,
- 11 2029" and inserting "October 21, 2029".
- 12 SEC. 4. DETERMINATION OF BUDGETARY EFFECTS.
- The budgetary effects of this Act, for the purpose of
- 14 complying with the Statutory Pay-As-You-Go Act of 2010,
- 15 shall be determined by reference to the latest statement
- 16 titled "Budgetary Effects of PAYGO Legislation" for this
- 17 Act, submitted for printing in the Congressional Record
- 18 by the Chairman of the House Budget Committee, pro-
- 19 vided that such statement has been submitted prior to the
- 20 vote on passage.
