1	SEC. 4. PROMOTING ENTREPRENEURSHIP AND SMALL
2	BUSINESS OPPORTUNITIES AT HISTORI-
3	CALLY BLACK COLLEGES OR UNIVERSITIES.
4	The Administrator shall—
5	(1) on an annual basis, provide to each histori-
6	cally Black college or university a list of each intern-
7	ship or employment opportunity available at the Ad-
8	ministration;
9	(2) actively promote the programs and re-
10	sources of the Administration that would be helpful
11	for entrepreneurs who are students at, or graduates
12	of, historically Black colleges or universities;
13	(3) work to ensure that the Strategic Alliance
14	Memorandums between the Administration and his-
15	torically Black colleges or universities are enforced
16	by developing and executing a strategic plan that ac-
17	complishes the goals set forth in those memoran-
18	dums;
19	(4) conduct outreach to historically Black col-
20	leges or universities to provide awareness with re-
21	spect to resources, services, and opportunities pro-
22	vided by the Administration; and
23	(5) in order to enhance transparency, when de-
24	scribing the efforts of the Administration to
25	strengthen the capacity of historically Black colleges
26	or universities to participate in applicable Federal

programs and initiatives in each plan prepared
 under section 2(c) of Executive Order 13779 (82
 Fed. Reg. 12499; relating to promoting excellence
 and innovation at historically Black colleges and uni versities), provide rationales for those efforts.
