Maryland Emergency Management Agency – Cybersecurity Coordination and Operations Office – Establishment

- 4 FOR the purpose of establishing the Cybersecurity Coordination and Operations Office 5 within the Maryland Emergency Management Agency (MEMA); providing for the 6 purpose of the Office; requiring the Director of MEMA to appoint an Executive 7 Director as head of the Office; requiring the Office to be provided with sufficient staff 8 to perform the Office's functions; requiring the Office to establish regional assistance 9 groups to deliver or coordinate support services to political subdivisions, agencies, or regions in accordance with certain requirements; authorizing the Office to hire or 10 11 procure regional coordinators; requiring a certain report annually; defining certain 12 terms; altering a certain definition; making technical changes; and generally relating to the establishment of the Cybersecurity Coordination and Operations Office within 13 14 MEMA.
