## A BILL

To direct the Secretary of Veterans Affairs to submit to the Committees on Veterans' Affairs of the Senate and the House of Representatives a report regarding the organizational structure of the Department of Veterans Affairs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “VA Management  
5 Alignment Act of 2017”.

1 **SEC. 2. REPORT ON THE ORGANIZATIONAL STRUCTURE OF**  
2 **THE DEPARTMENT OF VETERANS AFFAIRS.**

3 (a) REPORT.—Not later than 180 days after the date  
4 of the enactment of this Act, the Secretary of Veterans  
5 Affairs shall submit to the Committees on Veterans' Af-  
6 fairs of the Senate and the House of Representatives a  
7 report (including recommendations for legislation the Sec-  
8 retary considers appropriate) regarding the roles, respon-  
9 sibility, and accountability of elements and individuals of  
10 the Department of Veterans Affairs.

11 (b) MATTERS INCLUDED.—In creating the report  
12 under subsection (a), the Secretary shall—

13 (1) utilize the results of—

14 (A) the Independent Assessment of the  
15 Health Care Delivery Systems and Management  
16 Process of the Department of Veterans Affairs  
17 established by section 201 of the Veterans Ac-  
18 cess, Choice, and Accountability Act of 2014  
19 (Public Law 113–146);

20 (B) any study or report by the Commission  
21 on Care established by section 202 of the Vet-  
22 erans Access, Choice, and Accountability Act of  
23 2014 (Public Law 113–146); and

24 (C) other studies or reports, including a  
25 report titled “Task Force on Improving Effec-  
26 tiveness of VHA Governance: Report to the

1 VHA Under Secretary for Health”, dated Feb-  
2 ruary 28, 2015; and

3 (2) specify clearly delineated roles and respon-  
4 sibilities to optimize the organizational effectiveness  
5 and accountability of each—

6 (A) Administration, staff office, or staff or-  
7 ganization;

8 (B) subordinate organization of each Ad-  
9 ministration, staff office, or staff organization;  
10 and

11 (C) key leader of the Department in rela-  
12 tion to any Administration, staff office, or staff  
13 organization, Veteran Integrated Service Net-  
14 work, or medical facility.

15 (c) DEFINITION.—In this Act, the term “key leader  
16 of the Department” includes—

17 (1) the Secretary;

18 (2) the Deputy Secretary;

19 (3) each Under Secretary;

20 (4) each Assistant Secretary;

21 (5) each Deputy Assistant Secretary;

22 (6) the Chief Financial Officer;

23 (7) the Chief Information Officer;

24 (8) the General Counsel;

25 (9) the Inspector General;

- 1           (10) the Director of Construction and Facilities
- 2       Management;
- 3           (11) the Chief of Staff;
- 4           (12) the Chairman of the Board of Veterans'
- 5       Appeals;
- 6           (13) the Vice Chairman of the Board of Vet-
- 7       erans' Appeals;
- 8           (14) the Director of each Veterans Integrated
- 9       Service Network; and
- 10          (15) the Director of each medical facility.
