A BILL

To make emergency appropriations to the National Guard.

3 DEPARTMENT OF DEFENSE

4 MILITARY PERSONNEL

5 NATIONAL GUARD PERSONNEL, ARMY

6 For an additional amount for “National Guard Per-
7 sonnel, Army”, \$231,000,000, to respond to the events at
8 the United States Capitol Complex on January 6, 2021,

1 and for related purposes: *Provided*, That such amount is
2 designated by the Congress as being for an emergency re-
3 quirement pursuant to section 251(b)(2)(A)(i) of the Bal-
4 anced Budget and Emergency Deficit Control Act of 1985.

5 NATIONAL GUARD PERSONNEL, AIR FORCE

6 For an additional amount for “National Guard Per-
7 sonnel, Air Force”, \$28,900,000, to respond to the events
8 at the United States Capitol Complex on January 6, 2021,
9 and for related purposes: *Provided*, That such amount is
10 designated by the Congress as being for an emergency re-
11 quirement pursuant to section 251(b)(2)(A)(i) of the Bal-
12 anced Budget and Emergency Deficit Control Act of 1985.

13 OPERATION AND MAINTENANCE

14 OPERATION AND MAINTENANCE, ARMY NATIONAL GUARD

15 For an additional amount for “Operation and Main-
16 tenance, Army National Guard”, \$218,500,000 to respond
17 to the events at the United States Capitol Complex on
18 January 6, 2021, and for related purposes: *Provided*, That
19 such amount is designated by the Congress as being for
20 an emergency requirement pursuant to section
21 251(b)(2)(A)(i) of the Balanced Budget and Emergency
22 Deficit Control Act of 1985.

23 OPERATION AND MAINTENANCE, AIR NATIONAL GUARD

24 For an additional amount for “Operation and Main-
25 tenance, Air National Guard”, \$42,500,000 to respond to

1 the events at the United States Capitol Complex on Janu-
2 ary 6, 2021, and for related purposes: *Provided*, That such
3 amount is designated by the Congress as being for an
4 emergency requirement pursuant to section
5 251(b)(2)(A)(i) of the Balanced Budget and Emergency
6 Deficit Control Act of 1985.
