Election Law - References to Absentee Voting in Communications - Mail-In Voting Absentee Voting - References in Public Communications and Prepaid Postage for Return of Ballots

5	FOR the purpose of requiring the State Board of Elections and each local board of elections
6	to refer to absentee ballots as "mail-in ballots" and absentee voting as "mail-in
7	voting" in all communications with voters and the general public; requiring the State
8	Board and each local board to include in public communications regarding "mail-in
9	voting" a statement that "mail-in voting" is referred to as absentee voting in the
10	Maryland Constitution, the Annotated Code of Maryland, and the Code of Maryland
11	Regulations; providing for a delayed effective date; <u>requiring that certain envelopes</u>
12	required to be used by voters voting by absentee ballot to return their ballots include
13	prepaid postage; requiring that absentee ballots be accompanied by instructions for
14	the postage of certain absentee ballot envelopes; requiring the State Board of Elections
15	to reimburse each local board of elections for a certain percentage of the cost of prepaid
