## H. R. 9404

To amend the Public Health Service Act to prohibit the Secretary of Health and Human Services from placing any vaccine for COVID-19 on the child and adolescent immunization schedule unless the Secretary has posted on the public website of the Centers for Disease Control and Prevention all clinical data in the possession of the Department of Health and Human Services relating to the safety and efficacy of such vaccine, and for other purposes.

## A BILL

To amend the Public Health Service Act to prohibit the Secretary of Health and Human Services from placing any vaccine for COVID-19 on the child and adolescent immunization schedule unless the Secretary has posted on the public website of the Centers for Disease Control and Prevention all clinical data in the possession of the Department of Health and Human Services relating to the safety and efficacy of such vaccine, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Protecting Our Chil-
- 5 dren from the CDC Act".
- 6 SEC. 2. POSTING OF ALL CLINICAL DATA FOR COVID-19
- 7 VACCINES BEFORE PLACEMENT ON CHILD
- 8 AND ADOLESCENT SCHEDULE.
- 9 Part C of subtitle 2 of title XXI of the Public Health
- 10 Service Act (42 U.S.C. 300aa–25 et seq.) is amended by
- 11 adding at the end the following:
- 12 "SEC. 2129. POSTING OF ALL CLINICAL DATA FOR COVID-19
- 13 VACCINES BEFORE PLACEMENT ON CHILD
- 14 AND ADOLESCENT SCHEDULE.
- 15 "(a) No Inclusion of COVID Vaccines.—The
- 16 Secretary, and any official, agency, or office of the Depart-
- 17 ment of Health and Human Services (including the Cen-
- 18 ters for Disease Control and Prevention and the Advisory
- 19 Committee of Immunization Practices), shall not include
- 20 any vaccine for COVID-19 on the child and adolescent
- 21 immunization schedule unless the Secretary has posted on
- 22 the public website of the Centers for Disease Control and
- 23 Prevention all clinical data in the possession of the De-
- 24 partment of Health and Human Services (including the
- 25 Advisory Committee of Immunization Practices) relating

- 1 to the safety and efficacy (including any adverse effects)
- 2 of such vaccine. All such data posted under this subsection
- 3 shall be deidentified to protect all individually identifiable
- 4 health information, and information with respect to the
- 5 agency and sponsor personnel of the data involved.
- 6 "(b) Vaccines Already on Schedule as of En-
- 7 ACTMENT.—
- 8 "(1) Removal.—Any vaccine for COVID-19
- 9 that is included on the child and adolescent immuni-
- zation schedule as of the date of enactment of this
- section is hereby deemed to be removed from such
- schedule.
- 13 "(2) Administrative action.—The Secretary
- shall take such actions as may be necessary to effec-
- tuate the removal of a vaccine from the child and
- adolescent immunization schedule by operation of
- paragraph (1).
- 18 "(3) RULE OF CONSTRUCTION.—The removal
- of a vaccine from the child and adolescent immuni-
- 20 zation schedule by operation of paragraph (1) shall
- 21 not be construed to affect the authority of the Sec-
- retary (or other officials, agencies, or offices) to
- place such vaccine back on such schedule so long as
- such placement is in accordance with subsection (a)
- and other applicable provisions of law.

- 1 "(c) Definition.—In this section, the term 'child
- 2 and adolescent immunization schedule' means the child
- 3 and adolescent immunization schedule of the Advisory

4 Committee of Immunization Practices (or any successor

5 schedule).".
