Pursuant to 28 USC 1746, I, Francis A. Boyle declare under penalty of perjury that the statements contained herein are true and correct to the best of my knowledge.

I am Francis A. Boyle, a professor of international law at the University of Illinois College of Law. I received an AB (1971) in Political Science from the University of Chicago, then a JD degree magna cum laude from Harvard Law School, and AM and PhD degrees in Political Science from Harvard University.

I have advised numerous international bodies in the areas of human rights, war crimes and genocide, nuclear policy, and bio-warfare. In 1985 I publicly called for and then drafted the U.S. domestic implementing legislation for the Biological Weapons Convention, known as the Biological Weapons Anti-Terrorism Act of 1989, that was approved unanimously by both Houses of the U.S. Congress and signed into law by President George H.W. Bush with the approval of the United States Department of Justice. See my book *Biowarfare and Terrorism* (Clarity Press: 2005).

It is my expert opinion that, 'COVID-19 nanoparticle injections' or 'mRNA nanoparticle injections' or 'COVID-19 injections meet the criteria of biological weapons and weapons of mass destruction according to Biological Weapons 18 USC § 175; Weapons and Firearms § 790.166 Fla. Stat. (2023).

Chapter Twenty-Three: Plandemic Elites Broke Biological Weapons Anti-Terrorism Act:

Author of 1989 Law: Covid is a Bioweapon!

Interviewer: Francis Boyle is a human rights lawyer and Professor of International Law at University of Illinois College of Law. Professor Boyle has always been on the front line of any cause that he believes in. As a matter of fact, Professor Boyle was the lawyer for the government of Bosnia when it accused Serbia of genocide in the International Court of Justice. He's advocated in support of Hawaiian independence and even for a united Ireland. Well, since 2020, Professor Boyle has been one of the first and loudest voices arguing that the original COVID-19 virus was not natural but that it was, in fact, a bioweapon. And Professor Boyle knows a little bit about what bioweapons look like, because he wrote the laws about them. Literally. Back in the late 1980s, Boyle drafted the legislation for implementing the Biological Weapons Convention. His draft bill was enacted unanimously by Congress and signed by the first President Bush. It's Professor Boyle's belief that COVID-19 is an offensive biological warfare weapon that was released out of the lab in China. He believes that SARS from two decades ago was also a Chinese bioweapon as well. But most stunningly of all, he says that as bad as China's behavior

was, none of this would have happened without us contributing as well. Francis Boyle joins us now. Professor, thank you so much for coming. We appreciate it.

**Francis Boyle:** Well, thank you very much for having me. I'm just doing my best to your viewing audience, of course.

**Interviewer**: So we were really early in calling this a bio weapon. We were told that we were being hyperbolic and spreading misinformation. To that you say what?

Francis Boyle: Oh, well, I think history has proven us right. I first blew the whistle on this on January 24, 2020 in a worldwide alert to the news media on the internet, several 100 sources that the what would be called COVID-19 was an offensive biological warfare weapon with gain of function properties that had leaked out of the Wuhan BSL-4. We have to understand the Wuhan BSL-4 is China's Fort Detrick. Let me repeat that. The Wuhan BSL-4 is China's Fort Detrick. And since then, I think most people have come around to this conclusion.

Interviewer: Why is that not being broadcast?

Francis Boyle: Well, it's simple because, Stew, if you look at who was behind this, they are exercising censorship. In addition to the Wuhan BSL-4, we have Tony Fauci at NIAID, Francis Collins at the NIH, both of whom paid for this. You have the University of North

Carolina BSL-3. Ralph Baric, who cooperated with the Bat Queen of the Wuhan BSL-4. You have the Food and Drug Administration who helped develop this. Let me repeat that, the Food and Drug Administration who helped develop the COVID-19 biowarfare agent, is also involved in approving the so-called vaccines that basically give people cells of COVID-19, which is an offensive biological warfare weapon. So behind all this, we have the CDC, Walensky, Biden's appointee from the Harvard Medical School. Harvard Medical School was also involved in this. I have three degrees from Harvard, I condemn it in no uncertain terms. Harvard was a cooperating institution of the Wuhan BSL-4. The WHO was a cooperating institution of the Wuhan BSL-4. Imagine that Stew, if we knew the WHO was a cooperating institution, behind Fort Detrick, the cat would be out of the bag. Big Pharma is involved in this. We know Big Pharma has enormous advertising revenue over all U.S. news media. Bill Gates is behind this. He has contributed money to U.S. news media, so of course they're not going to report it.

**Interviewer:** So was this ever a respiratory virus?

**Francis Boyle**: Yes, of course. I pointed this out early on. If you look at, I don't know if it's still on there, but when I was researching it still in the Wuhan BSL-4 bragged on their website that they had aerosolized viruses. Let me repeat that. They bragged that they had

aerosolized viruses and the only reason you aerosolized virus is as a weapon. And they bragged. And indeed, they had over there, the head of the Harvard Chemistry Department, who was an expert on nanotechnology and applying nanotechnology to chemical weapons, biological weapons. He worked with Fort Detrick and Harvard knew it. Harvard's tried to cover this up, too. So yes, it was aerosolized, nanotechnologized, right from the very beginning. That is why, at the very beginning of the pandemic, we had reports from legitimate scientific researchers, that it spread by air up to maybe 30 feet. So this was well known at the beginning of the pandemic, but again, not reported.

**Interviewer**: Who would have had this information when this biowarfare was declared, and this weapon was deployed?

Francis Boyle: Stew, as far as I can figure out, the first evidence that came about that there was a problem over there to Wuhan BSL-4, was in early September of 2019. Now, when that happened, all our intelligence services had to do was to click on the computer programs over there by Tony Fauci and Francis Collins, NIAID and NIH, and they would have known full well exactly what was going on over there at Wuhan. Because we were paying for it. It was all in our computers. Our intelligence services knew even the there you know, the CIA, NSA, they all

knew and they all figured this out, in my opinion, quite early in September of 2019. I have all that in my book *Resisting Medical Tyranny* if you want to see the documentation on that so they knew

**Interviewer**: Yeah, of course. So I'm going to ask you to speculate, professor, who deployed the bioweapon?

**Francis Boyle:** Well, still, let me say this, it's in my opinion, the Chinese Communist government decided to develop this biological warfare weapon at their own Fort Detrick, because they wanted to play with the big boys.

Interviewer: What about Ralph Baric right here at home at the University of North Carolina Chapel Hill?

Francis Boyle: Yes, of course Baric did too. He worked on this yes with the Chinese Bat Queen and Wuhan BSL-4 they develop it. That's all here in this article, "SARS-like cluster of circulating back coronaviruses shows potential for human emergence" right there. It's in my book. Their names are all on there, including our own Fort Detrick, our own Fort Detrick was working at the UNC BSL-3, Stew. Right. They're all in on this.

**Interviewer**: So explain to me the difference between the SARS-CoV-2 whatever that is bioweapon, and this bioweapon injectable euthanasia heart attack causing clot shot.

Francis Boyle: There is no difference to what happens is in the first of all, we have to understand this mRNA technology was paid for, developed, financed, and envisioned by the Pentagon. Let me repeat that: paid for, financed, envisioned by the Pentagon, and its DARPA, Defense Advanced Research Program Agency. That's where this came from. And if you look at the technology behind what I call Frankenshots, these aren't vaccines, they actually give you a live cell of COVID-19, which is an offensive biological warfare weapon with gain of function properties, to make it more lethal, more infectious, and it also has HIV, the precursor of AIDS, DNA genetically engineered into that. That was determined by the Indian scientists and confirmed by Luc Montagnier, who won the Nobel Prize in Physiology. And that came out of the Wuhan BSL-4 going down to Australia to work with the Australian health lab down there on the DNA genetic engineering of HIV.

Interviewer: I've only got a couple of minutes left here but I think this is important.

What Pfizer and Moderna, AstraZeneca, J&J with these people, these big pharma manufacturers who are responsible for manufacturing and distributing these shots. Would they have been

instructed by the D.O.D. and made aware that they were creating a weapon of biowarfare to be deployed against Americans? Would they have known what they were doing?

**Francis Boyle**: I think you're all aware, right? That's correct. And, you know, it's just filthy lucre, they couldn't care less. They wanted to make money, you know, tens of billions of dollars. Thosebehind the Frankenshots. Yes, they know.

Interviewer: And they knew that it would cause infertility and sterility and spontaneous abortions and myocarditis and Guillain Barré and super cancers. They knew that this was going to happen, these white, fibrous clot looking like things, they knew all of that was going to happen.

Francis Boyle: Yes, and, and Stu, that is why I started a campaign to get them all indicted for murder and conspiracy to commit murder by state, local, public prosecutors here in the United States. It's not going to be done by the federal government, because they're in the tank with all these federal authorities.

**Interviewer**: Because they ordered it up, they declared bio warfare against its own people. Our government.

Francis Boyle: Right. And to give you an example of how evil this is, Stew, you know, I go through this in more detail in my book, but let's go back to the Nuremberg charter for the prosecution of the major Nazi war criminals, crimes against humanity, one of the three crimes there, and it is defined as quote, "namely, murder, extermination, and other inhumane acts committed against any civilian population". That's exactly what's going on here. This is a Nuremberg crime against humanity and all the individuals I mentioned today, and you mentioned, should be prosecuted for murder and conspiracy to commit murder by state local government authorities. I already had a 45-minute conversation with the Attorney General of Louisiana, going through his homicide statutes with him. And he agreed with me on my legal theory of the case that basically this is a political issue, not legal. And I also had a 35-minute conversation with the Deputy Attorney General of South Carolina, going through his homicide statute with him. He agreed with me on the legal theory of this case, that all these people could be indicted for murder and conspiracy to commit murder. It's basically a political question, Stew. I note here. I'm a political independent. I'm not appearing here to endorse Governor DeSantis. He was behind me at Harvard Law School, common law graduate, sharp guide, he asked the Florida Supreme Court to impanel, a grand jury to look into all of this. And I read the Terms of

Reference given by the Florida Supreme Court. And all this material, in my opinion, needs to go to the Florida grand jury and get indictments against all these people for murder and conspiracy commitment. My opinion is that if we get even one indictment of these people for murder and conspiracy to commit murder, this whole house of cards will collapse.

Interviewer: I agree. And we've been saying that for quite some time. Very quickly, because I'm over time yes or no answer. Professor, is there any state in our union that has a law that protects any individual or any company or any corporation or any government or any agency, is there any law that allows them to deploy a weapon of via warfare that would protect them and give them immunity for criminal prosecution?

Francis Boyle: Not from criminal prosecution, Stew. It is correct, that these people insulated themselves with prior legislation from being sued civilly to pay damages, but there is no statute anywhere that I am aware of that gives these people immunity from criminal prosecution for murder, conspiracy to commit murder, mayhem, also my Biological Weapons Anti-terrorism Act, but the problem there is that the federal government is not going to enforce my statute, because the federal government is up to its eyeballs in a Nuremberg crime against humanity against the American people. So we have to rely upon state and local prosecutors,

district attorney, state's attorneys, attorney generals which is why the conversations there in Louisiana, and also South Carolina.

Interviewer: Thank you for doing that. We need to move the ball forward now and have the conversation about accountability. These people need to be indicted and tried and found guilty for what they have done. They should be frightened. Professor Francis Boyle, thank you so much for making the time to be here today. We appreciate it.

**Francis Boyle:** Thanks for having me on and getting this message out to the American people, Stew. We're in the fight of our lives here.

The Covid 19 injections are biological and technological weapons of mass destruction. Self assembly nanotechnolology has been found in the injections and subsequently in human blood, initially the vaccinated, later the unvaccinated as well, from shedding.


An International research group of over 60 doctors, pharmacists and other professionals examined COVID vaccines from six different manufacturers: AstraZeneca, BioNTech/Pfizer, Moderna, Johnson & Johnson, Lubecavax and Influspit Tera. This group, known as the Working Group for COVID Vaccine Analysis, used scanning electron microscopy, energy dispersive X-ray spectroscopy, mass spectroscopy, inductively coupled plasma analysis, bright field microscopy, dark field microscopy and live blood image diagnostics. The preliminary analysis found toxic substances in all of the samples of COVID-19 vaccines— "without exception." These findings are consistent with a 2017 study of 44 different childhood vaccines that were examined for contamination. Various toxic metal contaminants not declared by the manufacturer were discovered in all 44 vaccines. Examples include

lead, tungsten and antimony. The researchers concluded that "adverse effects after the injection of those vaccines are possible and credible."2 More recently, another international research team examined hundreds of C-19 vaccine vials from Pfizer, Moderna, and AstraZeneca. They found "countless tiny sharp metal objects," leading one of the researchers to consider that severe effects from these impurities are "probably misdiagnosed by many pathologists as myocardial infarction."3 Similarly, stainless steel fragments were found in COVID vaccine vials in Japan.4 But metallic contaminants are among the least of the worries about the C-19 injections. Doctors from Italy published a study of Darkfield live blood microscopy of 1006 patients who received the Pfizer and Moderna Covid 19 bioweapon. This showed that 94% of individuals had self-assembly nanotechnology structures in their blood. 5


The most serious concern about the C-19 injections centers around the use of hydrogel polymers that self-assemble and self-spread. This is a substance created by nanotechnologies known to be in the C-19 vaccines. These nanotechnologies are what are called lipid nanoparticles, which include polyethylene glycol in the Pfizer vaccines and SM-102 in the Moderna vaccines.<sup>6</sup> I believe hydrogel is responsible for a silent surge of

deaths that the media is attributing to everything from cold showers to video games to climate change.<sup>7</sup>


My colleagues and I have chronicled the growth of nanotechnology hydrogel polymers in the C-19 vaccines<sup>8</sup>, vaccinated and unvaccinated blood. The growth process often begins with activity from quantum dots, which blink and change color.<sup>8</sup> Quantum dots, nano and microrobotsare a nano-scale technology that can transmit information and act as biosensors.



This activity is often followed by the aggregation of quantum dots into spheres.



The spheres then break open and create ribbon-like filaments. Using near infrared spectroscopy, I determined that these filaments are hydrogel polymers.<sup>9</sup>



These filaments, invade the body by growing continuously, even after death. 10



Later the hydrogel transforms the blood into sheets of polymer plastic. The image is microscopy of a blood clot from a vaccine injured individual. <sup>11</sup>



The obvious danger is that these hydrogel structures are in people's blood.

Eventually the hydrogel forms clots that can be seen with the naked eye.

And they pose a much greater health risk than normal blood clots.

This is what a normal blood clot looks like. It's a deep red, and it disintegrates when you pull it apart.



In contrast, this is a blood clot of a C-19 vaccinated person. <sup>12</sup> We see remnants of blood fused with a yellow, rubbery, plastic-like hydrogel substance. <sup>13</sup>



We are hereby confronting what is called bioplastics, a fusion of polymers and living organisms. Polyethylene, part of the polyethylene glycol in the Pfizer C-19 vaccine, is a well-known choice for making bioplastics.<sup>14</sup>


Unlike normal blood clots, a polymer bioplastic blood clot is far hardier and much harder to dissolve. <sup>15</sup> Clifford Carnicom and I tried to dissolve it with nine different reagents, including fuel injector cleaner, strong sulfuric acid, alcohol and lye. None of them made any difference, except for a minor reaction with lye. <sup>16</sup>



My work parallels the findings in the documentary Died Suddenly. In that documentary, an embalmer named Richard Hirschman said that in 2021 he started seeing "white fibrous structures" in the blood of deceased individuals that he embalmed. He said that eventually about 86 percent of his embalmed individuals had "significant clotting." <sup>17</sup>



Richard Hirschman sent me samples of these "white fibrous structures." I examined them and identified them as having the same hydrogel polymers and microrobots that we found in C-19 shots and in vaccinated blood. <sup>18,19</sup>



I have provided extensive video summaries of my work, which show the self assembly nanotechnology in C19 unvaccinated blood from shedding. It documents nano and microrobots, self assembly of polymer mesogen DNA biosensors. <sup>20,21,22</sup>.

Without taking action to dissolve this hydrogel, it becomes a ticking time bomb. Our own body's defenses against these impurities are far weaker than lye. I have witnessed heart problems in my new patients who come in

with significant amounts of hydrogel in their blood. All symptoms that are called long Covid, which include brain fog, fatigue, shortness of breath, heart palpitations and accelerated aging are correlated with these blood findings.

An additional threat to humanity from the hydrogel in these C-19 injections is perhaps the most sinister of all: transhumanism. Hydrogel is an extremely versatile substance that can mimic any cell in the body—including the brain. But it doesn't just mimic cells—it replaces them. I've witnessed the growth of hydrogel sheets in human blood, and how that growth results in a reduction of natural blood cells. This change in the body is nothing less than transhumanism, and affected people are unwittingly becoming cyborgs.

A recent MIT study actually lauds the many "hydrogel interfaces towards merging humans and machines." Another study<sup>24</sup> reports success in using hydrogel to achieve a "36.3 % enhancement in neurite extension," which means achieving a growth of synthetic cells in the brain. This is literally growing a parallel brain, which generates thoughts that are not your own. A third study "show[s] how hydrogel crosslinking inside bacterial cytoplasm under specific conditions can create nonreplicating yet metabolically active entities, which are herein termed Cyborg Cells." <sup>25</sup>

Why do these articles fail to question the ethics of changing humans into machines? As noted in an extensive journal review of transhuman initiatives, we are being led, largely unaware, into a new Bio-Nano Age, "brilliantly camoflaged" as "altruistic medical interventions." The eerie pronouncements of the Yuval Noah Harari of the World Economic Forum come to mind: "We will use Al and bioengineering to change Homo Sapiens and to create new kinds of beings that will be much more different from us than we are different from Neanderthals or from chimpanzees."

And so, from my research, my clinical experience, and my distrust of institutional pronouncements, I have arrived at firm conclusions about the C-19 vaccines. My conclusion is that they are an aggregation of poisons and nanotechnologies that cause a broad range of diseases, DNA devastations and deaths. The vaccine represents treason not only by our health care system, but by our own government, which has deliberately foisted a bioweapon upon its own citizens. The bane of this product is well summarized by Michael Yeadon, former vice president of Pfizer:

"I've spent 32 years in rational drug design. I know, and I knew, and wrote it, before any of them had emergency use authorization, that they were dangerous. And I'm afraid, I'm convinced and would say with my hand on the Bible in front of a court—a judge—that these

injections have been made to injure people—to maim and kill,

deliberately."28

I recommend a complete ban of the Covid 19 biological and technological

weapons and a moratorium on other mRNA drug delivery technologies.

Recent scientific study shows that lipid nanoparticles increase existing

inflammation and create new extreme inflammation via activation of

Galectin pathways which leads to cancers and all diseases of aging. 29
